

WE, the Ecclesiastical Commissioners for England, in consideration of a Benefaction of a capital sum of £500 heretofore held by us for the spiritual benefit of the Parish of Saint Andrew, Earlsfield, in the County of Surrey and in the Diocese of Southwark, and now specifically appropriated towards the endowment of the District of Saint John the Divine, Earlsfield, which has recently been formed partly out of the said Parish of Saint Andrew, Earlsfield, do hereby, in pursuance of the Act of the 29th and 30th years of Her late Majesty Queen Victoria, Chapter III, Section 5, Grant out of the Common Fund under our control to the Minister for the time being of the said District of Saint John the Divine, Earlsfield, and to his successors, and when such District shall have become a New Parish, then to the Vicar or Incumbent of such New Parish and to his successors, one yearly sum or stipend of £22 ros., such yearly sum or stipend to be calculated as from the 11th day of December, 1938, and to be payable in equal quarterly portions on the 1st day of February, the 1st day of May, the 1st day of August and the 1st day of November in each and every year: Provided always that the yearly sum or stipend hereby granted shall be and shall be taken to be in lieu of and in full substitution for the yearly sum or stipend of like amount heretofore payable by us towards the stipend of the Curate serving the Conventional District of Saint John the Divine, Earlsfield, in the said Parish of Saint Andrew, Earlsfield, under the Authority of an Instrument which was sealed by us on the 17th October, 1929, and was published in the London Gazette on the 29th October, 1929: Provided also that if at any time lands or other hereditaments sufficient in our opinion to produce the said yearly sum or stipend of £22 ros. or any part thereof, shall be annexed by us to the said District or New Parish of Saint John the Divine, Earlsfield, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of the said yearly sum or stipend or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.
