The KING's Most Excellent Majesty in Council.

WHEREAS His Majesty by Order in Council made the 16th March, 1933, ordered that Sir Roderick Sinclair Meiklejohn, K.B.E., C.B., and George Gillies Mennell, Esquire, C.B.E., and Leonard Blaikie, Esquire, should be His Majesty's Civil Service Commissioners for the purposes of and with the powers mentioned in the Order in Council made the 5th February, 1918, and the two Orders in Council both made the 22nd July, 1920 (being Orders making provision with respect to the appointment, tenure of office, powers and duties of His Majesty's Civil Service Commissioners), to hold their offices during the pleasure of His Majesty, the said Sir Roderick Sinclair Meiklejohn being First Commissioner, and the said George Gillies Mennell, Esquire, and Leonard Blaikie, Esquire, being Assistant Commissioners, holding also the offices, respectively, of Secretary to the Civil Service Commission and Director of Examinations:

And whereas the said Sir Roderick Sinclair Meiklejohn and the said Leonard Blaikie, Esquire, will retire from their offices as aforesaid on the 31st March, 1939:

Now, therefore, His Majesty, by and with the advice of His Privy Council, doth order, and it is hereby ordered, that as from the 1st April, 1939, Alexander Percival Waterfield, Esquire, C.B., and the said George Gillies Mennell, Esquire, and Charles Gilbert Nelson, Esquire, shall, subject to the provisions of the said Orders in Council made the 5th February, 1918, and the 22nd July, 1920, be His Majesty's Civil Service Commissioners for the purposes of and with the powers mentioned in the said Orders, the said Alexander Percival Waterfield, Esquire, being First Commissioner, and the said George Gillies Mennell, Esquire, and the said Charles Gilbert Nelson, Esquire, being Assistant Commissioners, holding also the offices, respectively, of Secretary to the Civil Service Commission and Director of Examinations.
