MINISTRY OF HEALTH.

Public Health (Imported Food) Regulations, 1937.

The Minister of Health gives notice, in pursuance of the above-named Regulations, that he hereby recognises each of the Official Certificates of which particulars are given in the Schedule hereto as showing (a) that the meat to which it relates or the meat from which the meat product to which it relates was prepared, was derived from animals inspected ante and post mortem and passed in accordance with criteria satisfactory to the Minister; and (b) that all necessary precautions for the prevention of danger to public health were taken in the dressing or preparing and packing of the meat or meat product.

Where the Certificate is in the form of a label, the recognition will apply only if the label is securely affixed to the meat or to the package containing the meat or meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate; and where the Certificate is in the form of a stamp, the recognition will apply only if the stamp is clearly impressed on the meat or the container, as the case may be.

The label or stamp hereby recognised as an Official Certificate for meat and meat products from the Union of South Africa, particulars of which are given in Part IV (1) of the Schedule hereto, is in substitution for the label having on it the design reproduced in Part XVII (1) of the Schedule to the Notice published in the London Gazette of the 6th August, 1937, which is hereby cancelled.
