

And whereas we, the Ecclesiastical Commissioners for England, have been requested by the incumbents of the said two benefices to substitute for the said charge an annual sum of the like amount charged on our Common Fund:

Now therefore we, the Ecclesiastical Commissioners for England, acting in pursuance of the Ecclesiastical Commissioners (Powers) Measure, 1938, section four, do hereby, subject as hereinafter mentioned, Grant out of our Common Fund to the Incumbent of the said Benefice of Saint Michael and All Angels, Radford, and to his successors incumbents of the same Benefice, one yearly sum or stipend of One hundred pounds to be calculated as from the 25th day of March, 1939, and to be in lieu of and in full substitution for the said annual sum charged upon the revenues of the said Benefice of Radford:

And we, the said Ecclesiastical Commissioners, do hereby appropriate for the benefit of our Common Fund as from the said 25th day of March, 1939, the sum of £2,857 2s. 10d. £3 10s. per cent. per annum Conversion Stock being a part of a larger sum of the same stock now held by us as part of the endowment of the said Benefice of Radford to the intent that from and after the same date the endowments of the said Benefice of Radford shall be discharged from the payment of the said annual charge of One hundred pounds.
