#### OFFENSIVE TRADES.

##### DECLARATORY ORDER.

SECTION 107 (1) (ii) (B) PUBLIC HEALTH ACT,  
1936.

NOTICE is hereby given that the City Council of Kingston-upon-Hull intend to apply to the Minister of Health for confirmation of an Order declaring the trades, businesses or manufactures (1) of receiving, storing, sorting or manipulating rags in or likely to be in an offensive condition or any bones, rabbit skins, fat or other putrescible animal products of a like nature; (2) of a manufacturer of feeding stuffs from fish, fish offal, blood or other putrescible animal matter and a manufacturer of oil from putrescible animal matter or a refiner of oil from fish, fish offal or putrescible animal matter to be offensive trades in the Borough.

And notice is hereby further given that the said Council will, at the expiry of one month from the date of publication of this notice, apply to the Minister of Health to confirm the order. If the order is confirmed, the effect will be to prevent the establishment, without the Council's consent, of any New Business of the kind above mentioned, and to give the Council greater power of making byelaws to regulate new and existing businesses. Any objection to the confirmation of the order may be made by letter addressed to the Secretary, Ministry of Health, London, S.W.1, before the order is confirmed.
