## COVENTRY CORPORATION.

(Alteration of Work.)

NOTICE is hereby given that when the Bill (hereinafter referred to as "the Bill") now pending in Parliament under the above name or short title was considered by the Committee of the House of Commons to whom the Bill was referred (in which Honourable House the Bill originated) provision was made for alterations of the line or situation of parts of the aqueduct or line or lines of pipes (Work No. 18) as described in the Bill as introduced into Parliament and delineated on the plans deposited in connection therewith in the month of November, 1938, with the respective Clerks of the County Councils of the Administrative Counties of Worcester and Warwick and with the Town Clerk of the City of Coventry (hereinafter referred to as "the originally deposited plans"). These alterations will be situate in the County of Worcester and are:—

Moor and partly in the parish of Fladbury in the rural district of Pershore commencing at a point on the line of the said Work as shown on the originally deposited plans in the property numbered 3 on those plans in the said parish of Hill and Moor 3 miles 6 furlongs 5.5 chains distant from the commencement of the said Work, passing through that parish and the said parish of Fladbury and terminating in the said parish of Hill and Moor at a point on the line of the said Work as so shown in the property numbered 6 on the said plans in the last named parish 5 miles 7 furlongs 2.6 chains distant from the commencement of the said Work.
