SHEEP SCAB MOVEMENT AND DOUBLE-DIPPING AREAS.

The following Areas are " Movement Areas " for the purposes of Part II of the Sheep Scab Order of 1938:—

*Inverness.*—An Area comprising:—

The Islands known as the Outer Hebrides (*except the Islands of St. Kilda, Dune, Soay, Bcrreray and Harris; and except the parish of North Uist and all the Islands therein, together with the island of Berneray in the parish of Harris and all the grazing islands attached thereto and the island of Barra and the adjacent islets attached to the holdings of Barra*), in the County of Inverness.

*Cardigan.*—An area comprising:—

So much of the County of Cardigan as lies within the following boundary, namely:—

Commencing at a point where the Cardigan-Radnor County boundary meets the southern boundary of the Parish of Yspytty Ystwyth at Esgair Hengae, thence in a generally westerly direction along the southern boundary of the Parish of Yspytty Ystwyth, to the point at Pont-rhyd-y-groes where it crosses the road running from Ffair-rhos via Tan-y-rhydiau to Yspytty Ystwyth, thence along that road in a northerly direction to the river Ystwyth, thence along the river in a westerly direction to the point near Tyn-y-bedw where the road from Crosswood Park to Ystrad Meurig crosses the river, thence along that road in a southerly direction to the point at Tyn-y-graig where the road meets the railway line running from Trawscoed Station to Strata Florida Station, thence in a southerly direction along that railway line via Strata Florida Station to Tregaron Railway Station, thence along the road leading from Tregaron Railway Station in an easterly direction via Diffws and Frwd-ar-gamddwr to the point where the said road meets the Cardigan-Brecon County boundary at Nantystalwyn, thence in a generally northerly direction along the Cardigan-Brecon and Cardigan-Radnor County boundaries to the point of commencement.

*Westmorland and Yorkshire.*— An area comprising:—

So much of the counties of Westmorland and the North and West Ridings of Yorkshire as lies within the following boundary, namely:—Commencing at Kirkby Stephen Church thence proceeding along the road in a southerly direction via Nateby and Outhgill to Moor Cock Inn, thence in a generally south westerly direction along the road via Garsdale Head, Dent Station, Cowgill House, Dent Church, Gawthrop and Peas Gill House to Barbon, thence in a generally northerly direction along the road via Middleton, Middleton Station, Borrett, Ingmire Hall, Wood Head, Firbank, Davy Bank and Roman Station to Tebay; and thence in an easterly direction along the road via Kellath, Ravenstonedale Station, Coldbeck and Kirkby Stephen Station to the point of commencement.

The movement of sheep out of the following area is regulated by the North Uist (Movement of Sheep) Order of 1934.

An area in the county of Inverness comprising the parish of North Uist and all the Islands therein, together with the island of Berneray in the Parish of Harris and all the grazing islands attached thereto.
