At the Court at *Buckingham Palace*, the 23rd day of *June*, 1939.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 23rd day of May, 1939 (C.E. 5274/39), in the words following, viz.:—

"Whereas by the twentieth section of an Act passed in the twenty-ninth year of Her late Majesty's reign, Chapter 89, entitled 'The Greenwich Hospital Act, 1865,' it is, amongst other things, enacted that the Admiralty shall, from time to time, continue to appoint such Officers, Clerks and Servants for the purposes of the Hospital and Schools as seem fit and may (subject to the approval of Your Majesty in Council) fix the salaries of such Officers and Clerks:

"And whereas by Order in Council bearing date the 9th March, 1939, the scale of salary of the Director of Greenwich Hospital was authorised to be at the rate and on the scale of £1,450 to £1,680 a year inclusive, rising by £100 a year, as from the 2nd January 1939:

"And whereas the above rate and scale of salary is the same as that paid to Principal Assistant Secretaries in Your Majesty's Civil Service before 1st April, 1939:

"And whereas the rate of pay of Principal Assistant Secretaries in Your Majesty's Civil Service has been increased to £1,700 a year, inclusive, as from 1st April, 1939.

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by

Your Order in Council to authorise that the salary of the Director of Greenwich Hospital shall be at the rate of £1,700 a year, inclusive, as from 1st April, 1939."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, *inter alia*, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:
