LAND DRAINAGE ACT, 1930.

Merionethshire Rivers Catchment Board.
Ardudwy Marsh Internal Drainage District.

Notice is hereby given that the Minister of Agriculture and Fisheries has made an Order under the Land Drainage Act, 1930, confirming a Scheme submitted to him by the Merionethshire Rivers Catchment Board, under Section 4 (1) (b) of that Act, making provision for the alteration of the boundaries of the Ardudwy Marsh Drainage District, the reconstitution of the Ardudwy Marsh Drainage Authority, and for certain matters supplemental thereto; and that the Order will become final and have effect as an Act of Parliament unless within thirty-one days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order shall not become law without confirmation by Parliament.

A copy of the sealed Order has been deposited, together with a copy of the Scheme, as amended, and of the map referred to in the Order, at the office of the Clerk of the Merionethshire Rivers Catchment Board, Tremeivion, Talsarnau, Merioneth, for public inspection for a period of thirty-one days from the date of this Notice, and may be inspected during the ordinary hours of business.
