The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of His Majesty's Treasury, viz.:—

#### SPECIAL REGULATIONS RESPECTING AN OPEN COMPETITIVE EXAMINATION FOR THE SITUATION OF DRAUGHTSMAN (UNESTABLISHED) IN THE HYDROGRAPHIC DEPARTMENT OF THE ADMIRALTY.

N.B.—*A Competition under these Regulations is open to candidates of either sex.*

1. The limits of age for this situation are 18 and 30; candidates must be of the prescribed age on the first day of the examination. A candidate who attained the age of 18 on the first day of the examination would be admitted, but a candidate who attained the age of 30 on that day would not be admitted.
