" And whereas by the Naval Forces Act, 1903, it is enacted that the Admiralty shall have power to raise and maintain a force to be called the Royal Naval Volunteer Reserve, and that any volunteer enrolling under this Act, when serving for training affoat or called out for actual service shall be deemed to be serving in Your Majesty's Naval or Marine Force within the meaning of the Naval and Marine Pay and Pensions Act, 1865:

"And whereas we are of opinion that the non-substantive rates of pay for Gunnery and the qualifications therefor, applicable to continuous service ratings of Your Majesty's Navy are not appropriate to members of Your Majesty's Naval Volunteer Reserve:

And whereas it is considered that the Gunnery non-substantive rates applicable to Your Majesty's Naval Volunteer Reserve should consist of two classes, viz.:—Higher Gunnery Rates and Gunnery Rates:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction payment of the rates set out in the annexed schedule.

# " Schedule.

"R.N.V.R. Gunnery Non-Substantive Rates.

I. Higher Gunnery Rates.

For higher qualifications required for certain duties with A.A. Long Range Units together existing Gunlayer and Rangetaker (R.N.V.R.) viz.:—Director Layer, Captain of Gun, Rangetaker, Range Operator or Plot Reader Gunlayer (R.N.V.R.) and Rangetaker (R.N.V.R.).

2. Gunnery Rates.

For lower qualifications, viz.:—Pointer Follower, Director Trainer, Left Gun Breechworker and Seaman Gunner (R.N.V.R.).

#### " Non-Substantive Pay.

1. Higher Gunnery Rates.

Leading Seaman and Able Seaman 9d. a day. Chief Petty Officer and Petty

Officer 6d. a day.

2. Gunnery Rates.

Leading Seaman and Able Scaman 3d. a day."

I. This Order may be cited as Tanganyika Order in Council, 1939, and shall be read and construed as one with the Principal

- 2. Article 19 of the Principal Order shall be amended by renumbering paragraph (4) as (5) and by inserting immediately after paragraph (3) the following paragraph:
  - '(4) No person shall be appointed to be a judge of the High Court unless:-
    - (i) He is qualified to practise as an advocate in a Court in England, Scotland, Northern Ireland or some other part of His Majesty's dominions having unlimited jurisdiction either in civil or criminal matters, or in the High Court, and

(ii) he has been qualified for not less than five years to practise as an advocate or solicitor in such a court."
