PETROLEUM (PRODUCTION) ACT, 1934.

In pursuance of Section 2 (3) of the Petro-leum (Production) Act, 1934, the Board of Trade hereby give notice that in accordance with the provisions of that Act and of the Petroleum (Production) Regulations, 1935, they have granted to the Gulf Exploration Company (Great Britain), Limited, of 3, London Wall Buildings, London, E.C.2, an extension of area of a Prospecting Licence previously granted to them, so as to embrace the additional lands referred to in the Schedule hereto.
