I declare that the present state of public affairs and the extent of the demands on My Military Forces for the protection of the interests of the Empire constitute a case of great emergency within the meaning of the Statutes severally enabling Me in that behalf.

A PROCLAMATION

FOR CALLING OUT THE ARMY RESERVE (INCLUDING THE MILITIA) AND EMBODYING THE TERRITORIAL ARMY.

GEORGE R.I.

WHEREAS by the Reserve Forces Act, 1882, it is, amongst other things, enacted that

in case of imminent national danger or of great emergency it shall be lawful for Us by Proclamation, the occasion being declared in Council and notified by the Proclamation if Parliament be not then sitting, to order that the Army Reserve shall be called out on permanent service; and by any such Proclamation to order a Secretary of State from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for calling out the said force or all or any of the men belonging thereto:

And whereas Parliament is not sitting, and whereas We have declared in Council and hereby notify that the present state of public affairs and the extent of the demands on Our Military Forces for the protection of the interests of the Empire constitute a case of great emergency within the meaning of the said Act:

And whereas by the Territorial and Reserve Forces Act, 1907, as subsequently amended by the Territorial Army and Militia Act, 1921, it is, amongst other things, enacted that immediately upon and by virtue of the issue of a Proclamation ordering the Army Reserve to be called out on permanent service, it shall be lawful for Us to order Our Army Council from

time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for embodying all or any part of the Territorial Army, and in particular to make such special arrangements as they think proper with regard to units or individuals whose services may be required in other than a Military capacity:

Now, therefore, We do, in pursuance of the Reserve Forces Act, 1882, hereby order that Our Army Reserve (including the Militia) be called out on permanent service, and We do hereby order the Right Honourable Leslie Hore-Belisha one of Our Principal Secretaries of State, from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for calling out Our Army Reserve (including the Militia) or all or any of the men belonging thereto:

And We do hereby further order Our Army Council from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for embodying all or any part of the Territorial Army, and in particular to make such special arrangements as they think proper with regard to units or individuals whose services may be required in other than a Military capacity.

Given at Our Court at Buckingham Palace, this first day of September, in the year of our Lord one thousand nine hundred and thirty-nine and in the Third year of Our Reign.

A PROCLAMATION

FOR CONTINUING SOLDIERS IN ARMY SERVICE.

GEORGE R.I.

WHEREAS by the Army Act it is, amongst other things, enacted that it shall be lawful for Us in case of imminent national danger or of great emergency by Proclamation, the occasion being if Parliament be not then sitting declared by the Proclamation, to order that the soldiers who would otherwise be entitled in pursuance of the terms of their enlistment to be transferred to the Reserve shall continue in Army Service, and by any such Proclamation to order Our Army Council from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for causing all or any of the soldiers mentioned in the Proclamation to continue in Army Service, and such soldiers shall accordingly continue to serve in Army Service for the same period for which they might be required to serve if they had been transferred to the Reserve and called out for permanent service by a Proclamation issued by Us under the enactments relating to the Reserve:

And whereas Parliament is not sitting, and whereas the present state of public affairs and the extent of the demands on Our Military Forces for the protection of the interests of the

Empire constitute a case of great emergency within the meaning of the said Act:

Now, therefore, We do, in pursuance of the said Act, hereby order that all soldiers who on or after this date would otherwise be entitled in pursuance of the terms of their enlistment to be transferred to the Reserve shall continue in Army Service until legally discharged or transferred to the Army Reserve:

And we do hereby order Our Army Council to give all necessary directions herein accordingly.

Given at Our Court at Buckingham Palace, this First day of September, in the year of our Lord one thousand nine hundred and thirty-nine and in the Third year of Our Reign.

A PROCLAMATION

FOR EXTENDING THE SERVICES OF TIME-EXPIRED MEN IN THE ROYAL NAVY.

GEORGE R.I.

WHEREAS by the ninth section of an Act passed in the Session of Parliament holden in the 16th and 17th years of the Reign of Queen Victoria, intituled "An Act to make better provision concerning the entry and service of seamen, and otherwise to amend the laws concerning Her Majesty's Navy," it is enacted that in case We shall by Proclamation call upon the seamen, or any class or classes serving in Our Navy, or such of them as may be required so to do, to extend the term of their services, any seaman to whom such Proclamation shall extend, and whose term of service shall have expired at the date of such Proclamation, or may expire while such Proclamation shall continue in force, shall be required to serve for a period of five years from the expiration of such term, if his services be so long required, and shall be liable to serve accordingly:

And whereas We, by and with the advice of Our Privy Council, deem it expedient to extend the service of all classes of men now serving in Our Navy whose term of service may have expired, or may expire, while this Proclamation shall continue in force:

We, by and with the advice aforesaid, do hereby order and direct that all classes of men now serving in Our Navy whose term of service may have expired, or may expire while this Proclamation shall continue in force, shall be required to serve for a period of five years from the expiration of their respective terms of service, if their services be so long required.

GEORGE R.I.

WHEREAS by the Reserve Forces Act, 1882, as applied to the Air Force Reserve and to the officers and men thereof by the Air Force Reserve Order, 1924, it is, amongst other things, enacted that in case of imminent national danger or of great emergency it shall be lawful for Us by Proclamation, the occasion being declared in Council and notified by the Proclamation if Parliament be not then sitting, to order that the Air Force Reserve shall be called out on permanent service; and by any such Proclamation to order a Secretary of State from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for calling out the said force or all or any of the men belonging thereto:

And whereas Parliament is not sitting, and whereas We have declared in Council and hereby notify that the present state of public affairs and the extent of the demands on Our Air Forces for the protection of the interests of the Empire constitute a case of great emergency within the meaning of the said Act, as so applied:

And whereas by the Territorial and Reserve Forces Act, 1907, as applied to the Auxiliary Air Force and to the officers and men of that Force by the Auxiliary Air Force Order, 1924, it is amongst other things enacted that immediately upon and by virtue of the issue of a Proclamation ordering the Air Force Reserve to be called out on permanent service, it shall be lawful for Us to order Our Air Council from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for embodying all or any part of the Auxiliary Air Force, and in particular to make such special arrangements as they think proper with regard to units or individuals whose services may be required in other than an air force capacity:

Now, therefore, We do, in pursuance of the Reserve Forces Act, 1882, as so applied, hereby order that Our Air Force Reserve be called out on permanent service, and We do hereby order the Right Honourable Sir Kingsley Wood, one of Our Principal Secretaries of State, from time to time to give and, when given, to revoke or

vary such directions as may seem necessary or proper for calling out Our Air Force Reserve or all or any of the men belonging thereto:

And We do hereby further order Our Air Council from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for embodying all or any part of the Auxiliary Air Force, and in particular to make such special arrangements as they think proper with regard to units or individuals whose services may be required in other than an air force capacity.

Given at Our Court at Buckingham Palace this First day of September, in the year of our Lord One thousand nine hundred and thirty-nine, and in the Third year of Our Reign.

FOR CONTINUING AIRMEN IN AIR FORCE SERVICE.

GEORGE R.I.

WHEREAS by the Air Force Act it is, amongst other things, enacted that it shall be lawful for Us in case of imminent national danger or of great emergency by Proclamation, the occasion being if Parliament be not then sitting declared by the Proclamation, to order that the airmen who would otherwise be entitled, in pursuance of the terms of their enlistment or re-engagement to be transferred to the Reserve shall continue in Air Force service, and by any such Proclamation to order Our Air Council from time to time to give and, when given, to revoke or vary such directions as may seem necessary or proper for causing all or any of the airmen mentioned in the Proclamation to continue in Air Force service, and such airmen shall accordingly continue to serve in Air Force service for the same period for which they might be required to serve if they had been transferred to the Reserve and called out for permanent service by a Proclamation issued by Us under the enactments relating to the Reserve:

And whereas Parliament is not sitting, and whereas the present state of public affairs and the extent of the demands on Our Air Forces for the protection of the interests of the Empire constitute a case of great emergency within the meaning of the said Act:

Now, therefore, We do, in pursuance of the said Act, hereby order that all airmen who on or after this date would otherwise be entitled in pursuance of the terms of their enlistment or re-engagement to be transferred to the Reserve shall continue in Air Force service until legally discharged or transferred to the Air Force Reserve:

And We do hereby order Our Air Council to give all necessary directions herein accordingly.

Given at Our Court at Buckingham Palace, this First day of September, in the year of our Lord one thousand nine hundred and thirty-nine and in the Third year of Our Reign.
