### TENDERS FOR TREASURY BILLS.

- I. The Lords, Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Bill Office, at the Bank of England, on Friday, the 15th September, 1939, at I o'clock, for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the War Loan Acts, 1914-1919, to the amount of £55,000,000.
- 2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the Tenderer on any business day from Monday, the 18th September, 1939, to Saturday, the 23rd September, 1939, inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny), which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 2 o'clock (Saturday 12 o'clock) on the day on which the relative Bills are to be dated.
- 7. In virtue of the provisions of Section 1 (4) of the War Loan Act, 1919, Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

Whereas it is provided by paragraph (I) of Regulation 17 of the Defence Regulations, 1939, that no person being either a British subject or a British Protected Person shall, without the permission of a Secretary of State or the Admiralty or of a person authorised by a Secretary of State or the Admiralty to grant permission for the purpose of this Regulation, voluntarily enter any enemy territory or voluntarily go aboard any vessel or aircraft being used in the service of a Power at war with His Majesty;

I do hereby direct that the permission of one of His Majesty's Superintending Consular Officers shall, in respect of any British subject or British Protected Person within the jurisdiction of such Consular Officer, be treated for the purpose of paragraph (1) of the said Regulation as if it were such permission as is mentioned in that paragraph.

### GENERAL LICENCE.

TRADING WITH THE ENEMY.

FEES IN RESPECT OF PATENTS, DESIGNS AND TRADE MARKS:

The Board of Trade, in pursuance of the powers conferred upon them by Section I of the Trading with the Enemy Act, 1939, and of all other powers enabling them in that behalf, do hereby authorise—

(I) the payment on behalf of any person not being an enemy of any fees necessary for obtaining the grant of or for obtaining the renewal of Patents, or for obtaining the registration of Designs or Trade Marks or the renewal of such registration, in enemy territory, and the payment to enemies of their charges and expenses in relation to the matters aforesaid;

(2) the payment on behalf of an enemy of any fees payable on application for or renewal of the grant of Patents, or an application for the registration of Designs or Trade Marks or the renewal of such registration in any country not being enemy territory and the payment on behalf of an enemy to persons not being enemies of their charges and expenses, in relation to the matters aforesaid, and the receipt of payments from an enemy in relation to the matters aforesaid;

Provided always that any payment on behalf of an enemy under this paragraph, unless it is made by a person who has an interest in or under the patent, design or trade mark in question, may be made by the person making the same only out of moneys—

(a) remitted by or on behalf of such

enemy, or
(b) held for or on account of such

and not by way of gift or by way of advancement or loan to or on account of such enemy.

DEFENCE REGULATIONS, 1939.

CONTROL OF TRADE BY SEA ORDER, 1939.

NOTICE BY BOARD OF TRADE.

The Board of Trade hereby give notice, in accordance with the Control of Trade by Sea Order, 1939, that on and from the 13th September, 1939, no ship to which Article 1 of the Order applies shall proceed to sea from any port on a voyage to which Article 1 (1) (a) applies, except under the authority of a licence granted by the Ship Licensing Committee (Overseas Voyages), Mercantile Marine Department, Board of Trade, Great George Street, S.W.1, to whom application in the prescribed manner should be made.

Application forms for this purpose may be obtained from the Secretary, Ship Licensing Committee (Overseas Voyages), at the above

The ships to which Article I of the Order applies are all British ships registered in the United Kingdom, the Channel Islands or the Isle of Man and having a gross tonnage of 100 tons or more, except fishing boats.

Article I (I) (a) applies to any voyage (from a port in any part of the world) that is not either a coasting voyage or a short sea voyage as defined in the Order.

A coasting voyage is defined in the Order as a voyage made wholly between ports within the United Kingdom, the Channel Islands and the Isle of Man.

A short sea voyage is defined in the Order as any voyage, other than a coasting voyage, from a port within the limits sixty-nine degrees North and forty-three degrees North latitude and eleven degrees West and thirty-one degrees East longitude, not being a port in the

Mediterranean, Adriatic or Black Seas or a port in Spain, to any other port within such limits not being a port in the Mediterranean, Adriatic or Black Seas or a port in Spain.

EMERGENCY POWERS (DEFENCE) ACT, 1939.

ORDER, DATED SEPTEMBER 6TH, 1939, MADE BY THE BOARD OF TRADE APPOINTING SEPTEMBER 6TH, 1939, AS THE DATE ON WHICH ARTICLE 13 OF AN ORDER-IN-COUNCIL DATED THE 2ND DAY OF SEPTEMBER, 1939, AMENDING THE DEFENCE REGULATIONS (ISLE OF MAN), 1939, SHALL COME INTO OPERATION.

The Board of Trade, in pursuance of the powers conferred upon them by paragraph (2) of Article 13 of an Order-in-Council, dated the 2nd day of September, 1939, amending the Defence Regulations (Isle of Man), 1939, do hereby order and appoint the sixth day of September, 1939, as the date on which Article 13 of the said Order-in-Council shall come into operation.

#### OPEN GENERAL EXPORT LICENCE.

Whereas by the Export of Goods (Prohibition) (No. 2) Order, 1939 (S.R. & O., 1939, No. 1024), the exportation of certain goods including the goods hereinafter mentioned was prohibited unless the exportation of the said goods is authorised by a licence of the Board of Trade.

Now, therefore, the Board of Trade do hereby authorise and permit the exportation of tobacco from any port in the United Kingdom

subject to the following conditions:

(I) That the owner or shipper of the said goods, if so required by the Commissioners of His Majesty's Customs and Excise, shall produce to them, within such time as they may allow, proof to their satisfaction that the said goods were duly delivered to the destination stated in the shipping documents;

(2) This licence may be modified or revoked at any time by the Board of Trade,

without reason given.

This licence shall come into force on the 11th September, 1939.

## CHARTS, SAILING DIRECTIONS AND HYDROGRAPHIC PUBLICATIONS.

NOTICE BY THE ADMIRALTY.

The Admiralty notify that all Charts, Sailing Directions, and other hydrographic publications, whether privately or official published, must in future be regarded as coming under Regulation 3 of the Defence Regulations, 1939.

This regulation forbids the obtaining, record-

This regulation forbids the obtaining, recording, publishing or communicating of any information of such a nature as is calculated to be or might be directly or indirectly useful to the enemy and likewise forbids any person to have in his possession, without lawful authority or permission, any document containing any such information.

All persons other than recognised Agents for their sale having copies of any such charts and publications in their possession should withhold them from sale, and dealings in copies of such charts and publications, whether by way of sale or otherwise, should only take place during the continuance of the War in the following manner:—

I. All charts and Hydrographic Publications for export will be packed and despatched by the Hydrographic Department, Admiralty.

2. Orders for Charts, Sailing Directions, or other Hydrographic publications whether for sale to persons within the United Kingdom or for export to any other country must be passed to a licensed Chart Agent, a list of which will be found in Admiralty Notice to Mariners No. 2 of 1939.

3. All such orders must be accompanied by a Certificate stating the charts, or Hydrographic publications will not be used to trade with or be supplied to a country or its subjects with which this country is at war. Order forms embodying the above-mentioned Certificate can be obtained from Admiralty Chart Agents:

4. The postage or shipment of any Chart or Hydrographic publication to any person or place out of the United Kingdom is not permitted except as laid down in 2 above.
