in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Saint John, Battersea, and of the said New Parish of Saint Mark, Battersea Rise, shall be altered so that (first) all that portion of the said New Parish of Saint Mark, Battersea Rise, which is described in the First Schedule hereunder written and is delineated and set forth upon the Map or Plan hereunto annexed and is thereon coloured pink, shall be dissevered from such New Parish and shall be annexed to and shall in future form part of the said New Parish of Saint John, Battersea and (secondly) all that portion of the Parish of Saint Anne, Wandsworth, in the said County of Surrey and in the said Diocese of Southwark, which is described in the Second Schedule hereunder written and is delineated and set forth upon the said Map or Plan hereunto annexed and is thereon coloured green, shall be dissevered from such Parish and shall be annexed to and shall in future form part of the said New Parish of Saint Mark, Battersea Rise.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULES to which the foregoing Scheme or Representation has reference.

"The territory to be dissevered from the New Parish of Saint Mark, Battersea Rise, in the County of Surrey and in the Diocese of Southwark, and to be annexed to the New Parish of Saint John, Battersea, in the said County and Diocese, being:—

"All that portion of the said New Parish of Saint Mark, Battersea Rise, which is bounded upon the west by the said New Parish of Saint John, Battersea, upon the north-east by the New Parish of Saint Peter, Battersea, in the said County and Diocese, and upon the remaining side, that is to say, upon the south-east, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Peter, Battersea, from the said New Parish of Saint Peter, Battersea, from the said New Parish of Saint Mark, Battersea Rise, at the junction of Plough Road with St. John's Hill, and extending thence south-westward along the middle of St. John's Hill for a distance of 6 chains or thereabouts to its junction with Plough Terrace upon the boundary which divides the said New Parish of Saint Mark, Battersea Rise, from the said New Parish of Saint John, Battersea.

"The Second Schedule.

"The territory to be annexed to the said New Parish of Saint Mark, Battersea Rise, being:—

"All that portion of the Parish of Saint Anne, Wandsworth, in the said County and Diocese, which is bounded upon the north by the New Parish of Saint Faith, Wandsworth, in the said County and Diocese, upon the northeast and upon the east by the said New Parish of Saint Mark, Battersea Rise, and upon the remaining sides, that is to say, upon the south and upon the west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Mark, Battersea Rise, from the said Parish of Saint Anne, Wandsworth, at the junction of Spencer Road with the road called North Side, Wandsworth Common, and extending thence westward along the middle of North Side, Wandsworth Common, for a distance of 15 chains or thereabouts to its junction with Marcilly Road and extending thence northward along the middle of Marcilly Road for a distance of 7½ chains or thereabouts to its junction with East Hill upon the boundary which divides the said Parish of Saint Anne, Wandsworth, from the said New Parish of Saint Faith, Wandsworth."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwark.
