And whereas by the Burial Act, 1855, it is provided that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time to vary any Order in Council made under the Burial Act, 1853, as to His Majesty, with such advice as aforesaid, may seem fit:

And whereas the Minister of Health, after giving to the Incumbent and the Churchwardens of the said Parish of Merthyr Tydfil 10 days' previous notice of his intention in that behalf, has made a Representation to His Majesty in Council, that, for the protection of the public

health, so much of the said Order in Council of the 7th March, 1860, as relates to the parish burial ground at Thomas Town aforesaid, should be varied as hereinafter directed:

And whereas by an Order in Council of the 23rd June, 1939, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 4th August, 1939, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the Burial Act, 1853:

Now, therefore, His Majesty, in exercise of the powers in that behalf conferred upon him by the said Acts, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, that so much of the said Order in Council of the 7th March, 1860, as relates to the parish burial ground at Thomas Town aforesaid shall be varied, so as to provide that burials shall be discontinued therein as follows, viz.:—

MERTHYR TYDFIL.—Forthwith and entirely in the parish burial ground at Thomas Town

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein, shall be paid in such manner and subject to such restrictions, conditions and provisions as

are from time to time directed by Order in

"And whereas by Order in Council dated 22nd January, 1920 (No. 86/C.W.), regulations concerning the titles and advancement of various Warrant Officers in Your Majesty's

Naval Service were approved:

"And whereas we consider that the needs of the Air Arm of Your Majesty's Fleet necessitate the institution of new categories of Warrant Officer and above:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction the institution of the ranks shown in the annexed Schedule A and the employment of officers in those ranks, at our discretion, under the conditions in the annexed Schedule B.

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in these proposals.

#### "SCHEDULE B.

"CONDITIONS OF SERVICE FOR WARRANT OFFICERS OF THE FLEET AIR ARM.

I. Warrant Pilots to be selected from Petty Officer Pilots or such other ratings as the Admiralty may from time to time prescribe.

Warrant Observers to be selected from Observers Mate or such other ratings as the Admiralty may from time to time prescribe. The title Warrant Observer to replace that of Boatswain Observer.

Warrant Aircraft Officers to be selected from Air Artificers.

Warrant Air Mechanics to be selected from Air Mechanics.

II. Warrant Pilots and above and Warrant Observers and above to be paid on the scale laid down for Executive Warrant Officers, and above.

III. Warrant Aircraft Officers and above and Warrant Air Mechanics and above to be paid on the scale laid down for Warrant Engineers and above.
