DOCKYARD PORTS REGULATION ACT, 1865.

NOTICE AND WARNING IN RELATION TO THE RESERVATION BY THE ADMIRALTY IN THE DOCKYARD PORT OF PEMBROKE OF AN AREA IN WHICH ANCHORING AND PASSING THROUGH WILL BE PROHIBITED.

In pursuance of the powers conferred upon them by Clause 8 of the First Schedule of the Order-in-Council dated the 26th day of September, 1891, made under the Dockyard Ports Regulation Act, 1865, and relating to the Dockyard Port of Pembroke, the Lords Commissioners of the Admiralty hereby give notice that it is necessary to reserve for Naval purposes an Area within the Dockyard Port of Pembroke.

(i) The limits of the area, extending between the entrance to Castle Pill and Horse Shoe Cove, in the vicinity of Newton Noyes Pier, are as follows:

Western limit.—From position (a), 320 degrees 2500 feet from the fixed red light at the western end of the above pier, in a 180 degrees direction for 1000 feet to (b).

Southern limit.—From (b) in a 130 degrees direction for 1900 feet to (c), thence in a 102 degrees direction for 2200 feet to (d).

Eastern limit.—From (d) in a 000 degrees direction for 700 feet to (e) at the eastern side of Horse Shoe Cove.

Northern limit.-The High Water line between (a) and (e).

(ii) The eastern and western limits of the above areas are marked as follows:

Shore end.-By a beacon painted white with triangular top mark at positions (a) and (e) above.

Seaward end by a buoy painted green and white.

And by virtue of the powers conferred upon them as aforesaid the Lords Commissioners of the Admiralty hereby further give notice and warning that after twenty-one days from the date hereof all anchoring within the said area so marked and all passing through the said area will be prohibited, and that no vessel may act in contravention of the said prohibition unless compelled to do so by stress of weather or to avoid accident; nor when the said area may be uncovered or nearly uncovered at low water may any person pass through or remain in it, unless by permission of and under arrangements as may from time to time be made by the Officer in Charge.
