At the Court at *Buckingham Palace*, the 11th day of *December*, 1939.

PRESENT,

The KING's Most Excellent Majesty in Council.

HIS MAJESTY, in pursuance of section one of the Emergency Powers (Defence) Act, 1939 (2 & 3 Geo. 6. c. 62), and of all other powers enabling Him in that behalf, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered that Regulation three of the Defence (General) Regulations, 1939, shall have effect as if at the end thereof there were inserted the following paragraph:—

"(2) If either House of Parliament in pursuance of a resolution passed by that House holds a secret session, it shall not be lawful for any person in any newspaper, periodical, circular or other publication, or in any public speech, to publish any report of, or to purport to describe, the proceedings at that session, except such report or description thereof as may be officially communicated through the Press and Censorship Bureau."
