FACTORIES ACT, 1937.

The Secretary of State for the Home Department hereby gives notice that on the 27th January, 1940, he made Regulations under sub-section (4) of Section 71 of the Factories Act, 1937, providing for different periods of employment for young persons under 16 years of age from those for other young persons and women employed in factories in which the weekly hours worked by such young persons must, under the Section, not exceed 44 or other figure less than 48.
