

scribed in the Schedule hereunder written, all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid become and be constituted a separate District for spiritual purposes and that the same shall be named 'The District of All Saints, Intake, Doncaster'.

"And we further recommend and propose that the whole right of patronage of the said District so recommended to be constituted and, when such District shall have become a New Parish as aforesaid, then of the said New Parish, and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in the said Leslie Stannard, Bishop of the said Diocese of Sheffield, and his successors for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of All Saints, Intake, Doncaster, being:—

"All that part of the New Parish (sometime Chapelry District) of Christ Church, Doncaster, in the County of York and in the Diocese of Sheffield, which is bounded upon the south-east by the Parish of Cantley, upon the east by the Parish of Kirk Sandall, upon the north by the New Parish of Saint Mary, Doncaster, all in the said County and Diocese, and upon the remaining sides, that is to say, upon the west and upon the south-west, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint Mary, Doncaster, from the said New Parish of Christ Church, Doncaster, at the junction of Thorne Road with Zetland Road and extending thence south-eastward along the middle of Zetland Road for a distance of 41 chains or thereabouts to its junction with Sandringham Road and extending thence south-westward along the middle of Sandringham Road for a distance of 15 chains or thereabouts to its junction with Town Moor Avenue and extending thence south-eastward along the middle of Town Moor Avenue for a distance of 17 chains or thereabouts to its junction with Grandstand Road and extending thence south-westward along the middle of Grandstand Road for a distance of 13 chains or thereabouts to its junction with the Great North Road and extending thence south-eastward along the middle of the Great North Road for a distance of 50 chains or thereabouts to the boundary which divides the said New Parish of Christ Church, Doncaster, from the said Parish of Cantley."

And whereas drafts of the said Scheme have, in accordance with the provisions of the secondly hereinbefore mentioned Act, been

transmitted to the Patrons and to the Incumbent of the New Parish of Christ Church, Doncaster, out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Incumbent has signified his assent to such Scheme:

And whereas no reply has been received from such Patrons although a period of more than one calendar month has elapsed since the said drafts were so transmitted:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Sheffield.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared and laid before His Majesty in Council a Scheme bearing date the 14th day of December, 1939, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting the union of the Benefice (being a Rectory) of Middleton Cheney and the Benefice (being a Vicarage) of Chacombe, both of which Benefices are situate in the County of Northampton and in the Diocese of Peterborough:

"Whereas Commissioners appointed at our request by the Right Reverend Claude, Bishop of Peterborough, pursuant to the provisions of the said Measures to inquire into and report upon the re-arrangement by way of union or unions of certain Benefices in the Diocese of Peterborough including the said two Benefices of Middleton Cheney and Chacombe duly made their Report to the said Bishop of Peterborough and therein recommended the union of the said two Benefices and the terms for effecting the union, and the said Bishop of Peterborough signified in writing his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two benefices which Scheme is based upon the terms recommended in the said Report but with the assent of the said Bishop of Peterborough embodies certain modifications thereof:

"And whereas the said Benefice of Middleton Cheney is now full, the Reverend William
