SCHEDULE.

The South Wales District (Coal Mines) Scheme, 1930, shall be amended as follows:— I. In Clause 79 of the Scheme by adding the following new sub-clause (4) as under:

(4) The Executive Board shall have power out of the District (General Expenses) Fund to pay and remunerate members of the Control Board and officers, servants and staff whether of the Executive Board or of the Control Board, and in addition thereto to pay out of that Fund annuities, pensions and such other sums as it thinks fit to any such person upon his or her retirement from the service of or on ceasing to be employed by the Executive Board or the Control Board, as the case may be, or upon his or her death or upon the happening of any other event which may be specified by the Execu-tive Board, and in connection therewith shall also have power to establish a Pensions Fund and to take out policies of insurance or indemnity and to make any payments due from the Executive Board to such Pensions Fund and under such policies of insurance or indemnity out of the District (General Expenses) Fund.

2. In the Third Schedule, Part I, Clause 4, of the Scheme, by deleting the words "remuneration and ".
