### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 20 OF 1940.

#### SUBJECT.

Contracts the Foot-and-Mouth Disease Infected Area around Frampton, Dorset, as from the 25th February, 1940, so as to comprise an area of approximately 5 miles radius round Infected Places at Frampton. This Area lies wholly in the county of Dorset.

### FOOT-AND-MOUTH DISEASE (INFECTED AREAS) SPECIAL ORDER No. 21 OF 1940.

#### SUBJECT.

Declares an Area of approximately 15 miles radius round an Infected Place at Thorganby, Lincoln (Lindsey), to be an Infected Area for

the purpose of preventing the spread of foot-and-mouth disease, to which Area the provisions of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1938 are applied. The Area subject to restrictions lies wholly in the county of Lincoln. (Parts of Lindsey.)

## TOWN AND COUNTRY PLANNING ACT, 1932.

### WEST SUSSEX COUNTY PLANNING SCHEME.

Parishes of Billingshurst, North Mundham and Sidlesham.

NOTICE is hereby given that (1) on the 13th day of February, 1940, the Minister of Health notified his approval of the resolution of the West Sussex County Council, dated the 21st day of July, 1939, deciding to prepare the above planning scheme with reference
