## DISEASES OF ANIMALS ACTS, 1894 TO 1937.

Notice is hereby given, in pursuance of section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made an Order dated 9th March, 1940, relating to the quarantine of a certain animal.
