**NOTIFICATION REGARDING CERTAIN  
AREAS IN THE OCCUPATION OF  
GERMANY.**

His Majesty's Principal Secretary of State for Foreign Affairs hereby gives notice, in amplification of his notifications of the 8th September, 1939, and the 1st January, 1940, published in the "Gazettes" of the 12th September, 1939, and the 2nd January, 1940, respectively, that the following must be regarded as areas in the occupation of Germany:—

The Kingdom of Denmark, excluding the Dependencies of Greenland and the Faroe Islands.

This notification does not apply to the Kingdom of Iceland.

His Majesty The KING has been graciously pleased to award the King's Police Medal for Gallantry to the late Mr. Arthur Clare Fryer, Indian Police, District Officer, Frontier Constabulary, North West Frontier Province Police, in recognition of his gallantry and complete disregard for his personal safety in leading a frontal attack upon a gang of some 80 armed hostiles in the Dera Ismail Khan District of the North West Frontier Province on the 10th March, 1940.

In the course of the engagement Mr. Fryer was dangerously wounded and has since died.
