### TRADE BOARDS ACTS, 1909 AND 1918, HOLIDAYS WITH PAY ACT, 1938, AND TRADE BOARDS AND ROAD HAULAGE WAGES (EMERGENCY PROVISIONS) ACT, 1940.

#### PERAMBULATOR AND INVALID CARRIAGE TRADE BOARD (GREAT BRITAIN).

*Proposal to vary minimum rates of wages (including holiday remuneration).*

The Perambulator and Invalid Carriage Trade Board (Great Britain) hereby give notice that they propose to vary minimum rates of wages at present set out in the Notices I. (25) and I. (27).
