The Civil Service Commissioners hereby give notice, in pursuance of Clause 13 of the General Regulations under the Order in Council of the 22nd July, 1920, that, with the approval of the Lords Commissioners of His Majesty's Treasury, they have prescribed that a fee of £3 shall be payable by candidates admitted to a Special Army Examination or exempted from attendance at such examination, provided that a candidate who is also competing at a concurrent Navy Entrance Examination and pays the fee prescribed in respect of that examination shall not be required to pay any further fee.

SPECIAL ENACTMENTS (EXTENSION OF TIME) ACT, 1940.

Whereas by Section 70 of the Mid-Wessex Water Act, 1935, it is provided that the Mid-Wessex Water Company (hereinafter called the Company) shall not later than in the Session of 1941 promote a Bill in Parliament containing proposals for securing greater uniformity in the rates and charges in the limits of supply:

And whereas the Company have made application to the Minister of Health for the issue of an Order under the Special Enactments (Extension of Time) Act, 1940, so as:—

(1) To extend to the Session of 1944, the period limited by the said section;

(2) For the purposes of the Application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order in force within the limits within which the Company are authorised to supply water as may be necessary or desirable:

And whereas it is proposed that an Order should be issued in compliance with the said Application:

Notice is hereby given that the Minister of Health will consider any objections or representations made in writing before the ninth day of September, 1940, by any person or body interested in the subject matter of the said Application and the proposed Order. Such objections or representations should be addressed to the Secretary, Ministry of Health, Whitehall, London, S.W.1, and copies of them should be sent at the same time to the Secretary of the Mid-Wessex Water Company, Frimley Green, Surrey.
