The KING has been graciously pleased to confer the Victoria Cross on the undermentioned airman, in recognition of most conspicuous bravery:

652918 Sergeant John HANNAH.

On the night of 15th September, 1940, Sergeant Hannah was the wireless operator/ air gunner in an aircraft engaged in a successful attack on enemy barge concentrations at It was then subjected to intense anti-aircraft fire and received a direct hit from a projectile of an explosive and in-cendiary nature, which apparently burst inside the bomb compartment. A fire started which quickly enveloped the wireless operator's and rear gunner's cockpits, and as both the port and starboard petrol tanks had been pierced, there was grave risk of the fire spreading. Sergeant Hannah forced his way through the fire to obtain two extinguishers and discovered that the rear gunner had had to leave the aircraft. He could have acted likewise, through the bottom escape hatch or forward through the navigator's hatch, but remained and fought the fire for ten minutes with the extinguishers, beating the flames with his log book when these were empty. During this time thousands of rounds of ammunition exploded in all directions and he was almost blinded by the intense heat and fumes, but had the presence of mind to obtain relief by turning on his oxygen supply. Air admitted through the large holes caused by the projectile made the bomb compartment an inferno and all the aluminium sheet metal on the floor of this airman's cockpit was melted away, leaving only the cross bearers. Working under these conditions, which caused burns to his face and eyes, Sergeant Hannah succeeded in extinguishing He then crawled forward, ascertained that the navigator had left the aircraft, and passed the latter's log and maps to the pilot.

This airman displayed courage, coolness and devotion to duty of the highest order and, by his action in remaining and successfully extinguishing the fire under conditions of the greatest danger and difficulty, enabled the pilot to bring the aircraft safely to its base.

Appointed a Companion of the Distinguished Service Order.

Acting Squadron Leader Stewart BADER (26151). Leader Douglas Robert

This officer has displayed gallantry and leadership of the highest order. During three recent engagements he has led his squadron with such skill and ability that thirty-three enemy aircraft have been destroyed. In the course of these engagements Squadron Leader Bader has added to his previous successes by destroying six enemy aircraft.

Awarded the Distinguished Flying Cross.

Acting Wing Commander David Wilson Reid

(32062).

One night in September, 1940, this officer successfully carried out a dive-bombing attack on an assembly of barges in Ostend Harbour. On arrival over the target area, he made reconnaissance runs at an altitude of 1,000 feet, during which he carefully selected the most vital parts to attack. He then climbed to 6,000 feet and made a dive attack to 500 feet, and obtained direct hits on the target with a stick of eight 250-lb. bombs. During the preliminary runs and the attack intense anti-aircraft fire seriously damaged his aircraft affecting its controls and shattering the pilot's compass and the rear gun hatches. Despite these difficulties Wing Commander Reid pressed home his attack with great determination, courage and skill, showing complete disregard for his personal safety.

Squadron Leader Ronald Gustave Kellett (90082), Auxiliary Air Force.

By his excellent example and personality this officer has been largely responsible for the success of his squadron which in one week destroyed thirty-three enemy aircraft, of which Squadron Leader Kellett has destroyed three. His leadership and determination in attacking superior numbers of enemy aircraft have instilled the greatest confidence in the other pilots of his squadron.

· Squadron Leader David Alwyne PEMBERTON

(33036).
This officer has displayed outstanding leadership since the return of his squadron from France. He has led the squadron on almost every operation during which time it has destroyed or damaged fifty-one enemy aircraft. His qualities of leadership and personal example have contributed largely to these successes.

Acting Squadron Leader William Steven GARDNER (37457).

One night in September, 1940, this officer successfully pressed home an attack, from 800 feet, on a concentration of barges in Ostend Harbour. During the preliminary reconnaissance of the target area and the bombing attack, the aircraft was subjected to intense and accurate anti-aircraft and tracer fire, but despite this opposition Squadron Leader Gardner obtained eight direct hits on the target. In pressing home his attack this officer displayed splendid qualities of determination, courage and skill, and his example and leadership have had an excellent effect on the squadron as a whole,

Acting Squadron Leader Sir Archibald Philip HOPE (90127), Auxiliary Air Force.

This officer has completed 107 operational flights since the commencement of He has destroyed four enemy hostilities. aircraft and shared in the destruction of He has displayed outstanding leadership and set an excellent example to

Acting Squadron Leader Alexander Vallance Riddell Johnstone (90163), Auxiliary Air Force.

This officer has proved himself to be a leader of ability and determination and has been mainly responsible for the high standard of morale in his squadron. He has destroyed four enemy aircraft of which one was shot down at night.

Flight Lieutenant Edward John (29090), Reserve of Air Force Officers.

This officer has destroyed seven enemy aircraft and damaged another five. By his outstanding leadership, skill and courage, he has proved an excellent example to all.

Acting Flight Lieutenant George Eric BALL

This officer has destroyed five enemy aircraft. He pursued one of these at night for fifty miles before shooting it down. excellent leadership has instilled great confidence in his flight.

Acting Flight Lieutenant Percy Stevenson Weaver (70719), Missing, believed killed.

This officer has displayed great courage and leadership. He has destroyed six enemy His excellent example has conaircraft. tributed materially to the fine standard that exists in his Squadron.

Officer Manfred Beckett Flying Count Czernin (37148).

This officer has displayed great keenness in his desire to engage the enemy, and has destroyed nine of their aircraft. In August, 1940, he led his section in a head-on attack on large formations of enemy aircraft, destroying three of them.

Flying Officer Jerrard Jeffries (39286).

This officer has led his flight with skill and His determined leadership and skilled training have contributed largely tothe success of his squadron. He has destroyed four enemy aircraft and severely damaged another two.

Flying Officer Howard Clive Mayers (77976), Royal Air Force Volunteer Reserve.

This officer has participated in a number of interceptions and has destroyed seven enemy aircraft and possibly three others. During a recent engagement, a cannon shell passed through the port wing of his aircraft making a hole four feet in diameter, but Flying Officer Mayers succeeded in bringing his aircraft safely to base. He has displayed great courage and a fighting spirit.

Flying Officer Desmond Annesley Peter McMullen (40002).

Since the commencement of hostilities this officer has been continuously engaged on operational flights, including the Dunkirk operations, the protection of shipping and intensive air fighting over this country. has destroyed seven enemy aircraft and shared in the destruction of others. He has displayed high qualities of leadership and determination.

Officer Herbert John WOODWARD Flying (70833).

This officer has destroyed five enemy aircraft and has displayed leadership and courage of a high order.

Pilot Officer BENNIONS George Herman (43354).

Pilot Officer Bennions has led his section He has destroyed with great distinction. seven enemy aircraft and possibly several others. His determination and coolness have had a splendid influence on his squadron as a whole.

Pilot Officer Peter Victor Boot (76455), Royal Air Force Volunteer Reserve.

During the period April to June, 1940, this officer was constantly employed on patrols in France. He has displayed great and resourcefulness and courage destroyed at least six enemy aircraft.

Pilot Officer Frank Henderson Denton (36238).

One night in September, 1940, although the enemy tried to tempt him with a dummy flare path, Pilot Officer Denton showed great resourcefulness and daring when he successfully attacked the aerodrome at Chartres, his primary target, from a very low altitude. Several nights later, having failed to locate his target in the Ruhr owing to most severe weather conditions, he decided to attack the docks and shipping at Flushing. He broke cloud at 1,000 feet and manœuvred until he was in a position to attack this target which he knew was heavily defended. Pilot Officer Denton dived through a devastating curtain of light flak and machine-gun fire in a most determined and courageous manner, and released his bombs at an altitude so low that the force of the explosions rocketed his aircraft several hundred feet in the Nevertheless, he was able to see large fires and explosions amongst the shipping and docks. He eventually, with great difficulty, brought his aircraft, with gaping holes through each wing, safely back to its base. Pilot Officer Denton has taken part in twenty-four major bombing raids over enemy territory. He is a determined and courageous captain, and carries the complete confidence of his crew and associates.

Pilot Officer Thomas GRIER (40907).

This officer has taken part in a considerable number of engagements against the enemy and has destroyed eight of their aircraft as well as sharing in the destruction of others. He has displayed great courage, keenness and devotion to duty.

Pilot Officer Eric Stanley Lock (81642), Royal Air Force Volunteer Reserve.

This officer has destroyed nine enemy aircraft, eight of these within a period of one week. He has displayed great vigour and determination in pressing home his attacks.

Pilot Officer Gavin John Lynes (42066).

One night in August, 1940, this officer took part in a raid on the transformer station at Kelsterbach. Whilst passing over the Dutch coast, the inter-communication gear of his aircraft became unserviceable. He decided to continue, however, and passed over his target at 7,000 feet, the actual area being obscured by cloud. As he was unable to pin-point the objective, he decided to descend below the clouds. He made several attempts to approach the objective, but had to carry out such violent evasive action on account of the intense anti-aircraft fire that he was unable to make a satisfactory run. Eventually, however, he managed to pass directly over the objective at 2,000 feet and he then released his bombs himself. dived down to 100 feet at high speed to avoid being hit and whilst escaping from the target, the flash of the bombs could be seen as they burst on the buildings and the reflection of the flames was visible on the clouds as the By his persistent aircraft left the area. determination and his outstanding skill as a pilot, Pilot Officer Lynes was able to destroy the primary objective in the face of heavy opposition. Since the 20th April, 1940, he has taken part in thirty-two major bombing operations over Norway, Holland, Belgium, France, Germany, and Italy.

Pilot Officer William Henry MILLINGTON

(42720).

In August, 1940, this officer was flying as a member of a section engaged on aerodrome guard patrol. Fifteen Dorniers escorted by a large number of Messerschmitts were sighted and an attack was ordered. Pilot Officer Millington succeeded in damaging a Dornier, but was in turn engaged by three Messerschmitts. He damaged one, shook off the other two and, single-handed, again engaged the bombers. During a further attack by two of the enemy fighters, he shot down one but a cannon shell burst in the engine of his aircraft causing it to burn. Pilot Officer Millington, although suffering from a wound, chose to make a crash landing rather than abandon his aircraft and so endanger a village in front of him. He succeeded in getting clear just before the petrol tanks exploded. A few days previously, he attacked a formation of about sixty Heinkels, two of which he destroyed. He has displayed great courage in attacking superior numbers of enemy aircraft.

Pilot Officer Jack Stuart Simson (42681).

One night in August, 1940, this officer attacked the German warship Gneisenau, in the floating dock at Kiel from 800 feet in the face of intense enemy anti-aircraft fire and searchlights. He dropped a stick of bombs successfully across the target. Since the 17th June, 1940, Pilot Officer Simson has taken part in eighteen raids over Germany. As captain of aircraft he has displayed outstanding tenacity, determination and devotion to duty, and has at all times set a very high standard.

Pilot Officer Timothy Ashmead Vigors (33554). This officer has displayed great keenness in his desire to engage the enemy. He has destroyed nine enemy aircraft including one His excellent leadership and at night. determination have contributed materially to the many successes of his flight.

Awarded the Distinguished Flying Medal.

565510 Sergeant Ernest Edward Collins. 526730 Sergeant Robert Steen Ayron.

One night in September, 1940, Sergeant Collins was the pilot and Sergeant Ayton the navigator and bomb aimer of an aircraft which successfully carried out dive bombing attacks on a concentration of barges at Ostend Harbour. On arrival over the target area, reconnaissance runs were made during which the three most vital parts of the target were selected as objectives. The splendid qualities of piloting and planning of Sergeant Collins coupled with the accurate navigation and skilful bomb-aiming of Sergeant Ayton resulted in three successful dive attacks, in which direct hits were made. Three nights previously, these airmen together carried out a dive-bombing attack from 11,000 feet to 2,000 feet when direct hits destroyed large buildings of a factory and six chimney stacks. A large fire followed which was visible for 70 miles. Sergeant Collins has a fine record of good work in over 200 hours of operational flying, while Sergeant Ayton has displayed skill, efficiency and coolness under harassing conditions.

Sergeant Jozef Frantisek.

This officer has participated in almost every operational flight carried out by his squadron. He has displayed conspicuous gallantry in attacking superior numbers of enemy aircraft and has destroyed five of them within a period of one week. He has set an excellent example to other members of his flight.

514143 Flight Sergeant Adrian Francis Laws. This airman has destroyed five enemy aircraft and damaged another two. initiative, courage and tenacity have been outstanding.

590289 Flight Sergeant George Cecil Unwin.

This airman has displayed great courage in his attacks against the enemy and has destroyed ten of their aircraft. On a recent occasion, when returning from an engagement alone, he intercepted a formation of enemy bombers escorted by about thirty fighters, and destroyed two of the fighters. He has displayed skill and courage of the highest order.

740484 Sergeant Basil Ewart Patrick WHALL, Royal Air Force Volunteer Reserve.

During a period of operations in Norway under extremely difficult conditions, this airman destroyed three enemy aircraft. Since returning to England he has continued to display great zeal and determination and has succeeded in destroying a further four enemy aircraft during recent combats.
