VISITING FORCES (BRITISH COMMONWEALTH) ACT, 1933.

This day, the Lords being met, a message was sent to the Honourable House of Commons, by the Gentleman Usher of the Black Rod, acquainting them that The Lords, authorised by virtue of a Commission under the Great Seal, signed by His Majesty, for declaring His Royal Assent to the Acts agreed upon by both Houses, do desire the immediate attendance of the Honourable House in the House of Peers to hear the Commission read; and the Commons being come thither, the said Commission, empowering the Lord Archbishop of Canterbury, and several other Lords therein named, do declare and notify the Royal Assent to the said Acts, was read accordingly, and the Royal Assent given to:—

TENDERS FOR TREASURY BILLS.

I. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 1st November,

1940, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939 and 1940, to the amount of £65,000,000.

- 2. The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the Tenderer on any business day from Monday, the 4th November, 1940, to Saturday, the 9th November, 1940, inclusive, and will be payable at three months after date.
- 3. The Bills will be issued and paid at the Bank of England.
- 4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.
- 5. Tenders must be made through a London Banker, Discount House or Broker.
- 6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.
- 7. Members of the House of Commons are not precluded from tendering for these Bills.
- 8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.
- The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.

ROYAL AIR FORCE.

The KING has been graciously pleased to approve the following appointment and awards in recognition of gallantry displayed in flying operations against the enemy:—

Appointed a Companion of the Distinguished Service Order.

Squadron Leader Ronald Gustave Kellett, D.F.C. (90082), Auxiliary Air Force.

Squadron Leader Kellett as commander of his squadron has built up and trained his personnel to such a fine fighting pitch that no fewer than 113 enemy aircraft have been destroyed in the space of one month, with very few casualties sustained by his squadron. He has frequently led the wing formation with judgment and success. The gallantry and fine leadership displayed by Squadron Leader Kellett have proved an inspiring example.

Awarded a Bar to the Distinguished Flying Cross.

Flight Lieutenant Robert Findlay BOYD, D.F.C. (90165), Auxiliary Air Force.

This officer has personally destroyed at least 12 enemy aircraft, and has assisted in the destruction of one other. His fine leadership has enabled his squadron to attain many successes with few losses to themselves. Flight Lieutenant Boyd has distinguished himself by his cool bearing and capable leadership.

Flight Lieutenant Roland Robert Stanford Tuck, D.F.C. (37306).

Since the 11th June, 1940, this officer has destroyed six enemy aircraft, and probably destroyed or damaged six more. One day in August, 1940, he attacked three Junkers 88's, destroyed two and damaged the third. Later in the month he intercepted two Junkers 88's at 15,000 feet, and in a headon attack destroyed one. In a similar attack on the second, a cannon shell blew away his oil and glycol tank and a piece of his propellor, but he reached the coast and landed by parachute. In September, 1940, he shot down one Messerschmitt 110 and probably a Messerschmitt 109, and one week later destroyed a Messerschmitt 100 over the sea. Flight Lieutenant Tuck has displayed gallant and determined leadership.

Flying Officer Brian John George CARBURY, D.F.C. (40288).

Flying Officer Carbury has displayed outstanding gallantry and skill in engagements against the enemy. Previous to 8th September, 1940, this officer shot down eight enemy aircraft, and shared in the destruction of two others. Since that date he has destroyed two Messerschmitt 109's and two Heinkel 113's, and, in company with other pilots of his squadron, also assisted in the destruction of yet another two enemy aircraft. His cool courage in the face of the enemy has been a splendid example to other pilots of his squadron.

Awarded the Distinguished Flying Cross.
Group Captain Stanley Flamank VINCENT,
A.F.C.

Group Captain Vincent has been observing his wing from the air and up to the end of September, 1940, has made some dozen sorties alone. One day in September, 1940, he met 15 Dornier 215's and turned them back, damaging one. Later in September, 1940, he destroyed one of a large enemy formation, and created so much confusion that another Messerschmitt 109 was shot down by its own pilots. He is a born leader and has brought the efficiency of his station to a very high level.

Squadron Leader Henry Algernon Vickers Hogan (26181).

This officer has led his squadron with distinction. Sixty-nine hostile aircraft have been destroyed and many others damaged. Three of this number were destroyed by Squadron Leader Hogan personally.

Flight Lieutenant John Alexander Kent, A.F.C. (37106).

Early in October, 1940, this officer, when entirely alone, attacked 40 Messerschmitt 199's, and shot down two of them. He has personally destroyed at least four enemy aircraft. Flight Lieutenant Kent has been responsible in a large measure for the fighting efficiency of his squadron and has materially contributed to its successes. He has proved himself a born leader,

Flight Lieutenant Gordon Roy McGregor (936), Royal Canadian Air Force.

This officer has destroyed at least three enemy aircraft, and has damaged many others. He has led his flights and frequently the squadron with gallantry and dash.

Acting Flight Lieutenant James Michael Bazın (90281), Auxiliary Air Force.

This officer has shot down some ten enemy aircraft. He himself was shot down on one occasion, over enemy territory, but with amazing initiative and determination rejoined his unit within 24 hours. In August, 1940, he destroyed two enemy aircraft in raids on the North-East coast, and in September, 1940, he led two squadrons in a head-on attack against 100 to 120 enemy aircraft. The enemy were completely non-plussed and fled. As a leader Flight Lieutenant Bazin has shown marked ability and initiative,

Acting Flight Lieutenant Frank Jonathan Howell (39612).

This officer has shot down four enemy aircraft, has been partly responsible for the destruction of five more and has damaged several others. He has led both the squadron and his flight with skill and determination, which have undoubtedly contributed greatly to recent successes. Flight Lieutenant Howell's keenness and energy combined with his courage and leadership in many combats have set a splendid example to the rest of the squadron.

Acting Flight Lieutenant Charles Brian Fabris KINGCOME (33319).

Flight Lieutenant Kingcome has personally destroyed six enemy aircraft and by his leadership has been responsible for the destruction of many others. He has led his flight, and lately his squadron, with judgment, skill and keenness.

Flying Officer John Reynolds Cock (40674).

This officer has destroyed seven enemy aircraft. In August, 1940, when in action against a large formation of enemy aircraft, he attacked and destroyed a Junkers 88. During this combat he was attacked from below and his aircraft caught fire. Though wounded, he escaped by parachute and fell into the sea, but saved himself by swimming ashore. Flying Officer Cock has shown magnificent courage and initiative against overwhelming odds.

Flying Officer Blair Dalze Russell (1319), Royal Canadian Air Force.

Officer Russell has personally destroyed five enemy aircraft and has assisted in the destruction of a sixth. He has shown great keenness to attack the enemy.

Flying Officer Brian Van Mentz (70826).

Flying Officer Van Mentz has been engaged in operations against the enemy since the outbreak of war. He has destroyed six enemy aircraft and probably a further three, two of which were shot down during the period of intensive operations in France. This officer has led his section, and at times his flight, with skill and courage and has shown great determination in pressing home his attacks against large enemy formations.

Officer Anthony Charles BARTLEY

(41816).

Pilot Officer Bartley has shot down at least eight enemy aircraft. He has always displayed great coolness in action and proved himself a clever and determined fighter.

Pilot Officer Ronald BERRY (78538), Royal Air

Force Volunteer Reserve.

Pilot Officer Berry has personally destroyed six enemy aircraft, and assisted in the destruction of several others. Through innumerable engagements with the enemy he has shown the greatest gallantry and determination in pressing home his attacks at close The skill and dash with which this range. officer has led his section have done much to assure their successes.

Pilot Officer Charles Trevor Davis (33563).

Pilot Officer Davis has destroyed enemy aircraft. He has displayed great d He has displayed great dash and courage in his many combats, and his gallantry in fighting against any odds has been conspicuous.

Pilot Officer William Henry Hodgson (36269). In August, 1940, Pilot Officer Hodgson took part with his squadron in an engagement against more than 250 enemy aircraft, severely damaging several of them. Two days later he operated with his squadron against 150 bombers and fighters and on this occasion destroyed two Messerschmitt 110's, and damaged a Heinkel III. Later in August, 1940, during an engagement against 30 Dornier 215's, escorted by about 100 enemy fighters, he attacked one of the Dornier 215's head-on, severely damaged it, and then engaged and shot down a Messerschmitt 109. Although Pilot Officer Hodgson's aircraft was hit and set on fire by a cannon shell, he managed to keep the fire under control until he had effected a landing some distance away. By so doing he undoubtedly avoided causing civilian casualties. This officer has exhibited bravery of a high order and a complete disregard of his own personal safety.

William McKenzie Pilot Officer Kenneth (84017), Royal Air Force Volunteer Reserve. Early in October, 1940, whilst on patrol, this officer sighted a formation of eight Messerschmitt 109's. He attacked and damaged one of them which dived to sea level. Having expended all his ammunition, Pilot Officer McKenzie flew alongside the hostile aircraft and endeavoured unsuccessfully to force the enemy into the sea. Undeterred he severed the tail-plane of the Messerschmitt with his wing tip. Subsequently he was attacked by a number of Messerschmitt 109's, and although his aircraft was severely damaged he succeeded in reaching land and made a crash landing. In one week, Pilot Officer McKenzie has destroyed five enemy aircraft. His skill and gallantry have been of the highest order.

Awarded the Distinguished Flying Medal.

742134 Sergeant Cyril Frederick BABBAGE, Royal Air Force Volunteer Reserve.

Sergeant Babbage has shown consistent keenness and ability in operations against the enemy. He has personally destroyed six enemy aircraft and probably one other.

740896 Sergeant Harold Norman Howes,

Royal Air Force Volunteer Reserve.

During the period of intensive operations in Sergeant Howes destroyed four enemy aircraft. In August, 1940, he took part in attacks against large enemy formations. He personally destroyed two Messerschmitt 110's and one Dornier 215, and severely damaged several others. Sergeant Howes has proved himself a brave and determined pilot.

1256954 Sergeant Thomas Young WALLACE.

In a period of three weeks, Sergeant Wallace has destroyed seven enemy aircraft and probably another four. On one occasion he became separated from his squadron and, single-handed, pursued a formation of enemy bombers back to the French coast. While in mid-channel he was attacked by six enemy fighters, and although his aircraft was severely damaged in the resulting battle, he shot down one enemy aircraft and damaged another. Sergeant Wallace has displayed conspicuous courage and fighting ability.
