**RULES PUBLICATION ACT, 1893.****ROAD TRAFFIC ACT, 1930.**

The Minister of Transport hereby gives notice under the Rules Publication Act, 1893, that he proposes after the expiry of at least forty days from this date in pursuance of the powers conferred upon him by the Road
