### Amendment to Regulation 26.

Add the following paragraph at the end of the Regulation:—

" or (6) if he was in the Armed Forces of the Crown (other than the Home Guard) at any time between January 1st and August 1st, 1940, provided that he applies for registration within six months after demobilisation or discharge and provided also that he would have been qualified for admission under Section 2 of the Architects Registration Act, 1938, or under paragraph (2) or (5) of this Regulation if he had made application before the 1st August, 1940." ### TENDERS FOR TREASURY BILLS.

1.
