WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measures, 1923 to 1936, duly prepared and laid before His Majesty in Council a Scheme bearing date the 28th day of November, 1940, in the words and figures following, that is to say:

the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for authorising the appropriation of the disused Church known as the Church of Saint Anne, Ambleside, situate in the Parish of Ambleside in the County of Westmorland

and in the Diocese of Carlisle.
"Whereas the said Church of Saint Anne, Ambleside, is a consecrated Church and has been closed for some years and is no longer required for purposes of Divine Service and it has been represented to us, the said Ecclesiastical Commissioners, and it appears to us to be expedient that such Church should be appropriated for certain educational, charitable, or other purposes as hereinafter

recommended and proposed:
"And whereas the Reverend Henry Adamson Thompson is the present Incumbent of the Benefice

of Ambleside:

"Now, therefore, we, the said Ecclesiastical Commissioners, with the consents of the Right Reverend Henry Herbert, Bishop of Carlisle, and of the said Henry Adamson Thompson (testified by their respectively signing this Scheme), do humbly recommend and propose to Your Majesty that so soon as conveniently may be after the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme the said Church of Saint Anne, Ambleside shall be appropriated for educational, charitable, or other purposes in connection with the Church of England having in view the spiritual, intellectual, moral or social welfare of the parishioners of the said Parish of Ambleside and others and subject to such conditions regulations and provisions as the Bishop of Carlisle shall by Deed made pursuant to the 24th Section of the said Union of Benefices Measure, 1923, declare and appoint.

"Provided always that the provisions herein contained shall not take effect until the consents and approval which by the said Union of Benefices Measure, 1923, are made requisite to the appropriation of any Church under the powers conferred by that Measure shall be obtained to the appro-priation hereby proposed for the said Church of

Saint Anne, Ambleside.

"And provided further that nothing herein contained shall prevent us from making any other recommendations or proposals relating to the matters aforesaid or any of them in accordance with the provisions of the said Measures or of amy other Measure of the National Assembly of the Church of England or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Measures, and Notices have been transmitted to the persons or bodies entitled under the said Measures to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Measures

Amd whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Carlisle has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved

by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measures.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Carlisle.
