

the present war it shall not be an infringement of that Regulation for a new vehicle used under a Limited Trade Licence in the course of its delivery to a purchaser or to a port for export to carry any load so long as that load is not carried for hire or reward.

ROAD TRAFFIC ACT, 1930.
