to the Patrons and to the Incumbents of the Parish of Handsworth and of the New Parishes of Saint James, Handsworth Woodhouse, and Christ Church, Gleadless, out of which it is intended that the District recommended in such Scheme to be constituted shall be taken, and such Patrons and Incumbents have respectively signified their assent to such Scheme:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Sheffield.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94; of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94; and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, duly prepared and laid before His Majesty in Council a Scheme or Representation, bearing date the 16th day of January, 1941, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the 7th and 8th years of Her late Majesty Queen Victoria, Chapter 94, of the Act of the 13th and 14th years of Her said late Majesty, Chapter 94, and of the Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme or Representation for altering the boundaries of the New Parish of Knowle in the County of Warwick and in the Diocese of Birmingham:

"Whereas by an Order of Her said late Majesty in Council dated the 11th day of January 1859 and published in the London Gazette on the 18th day of the same month part of the Parish of Hampton-in-Arden in the said County of Warwick and at that time in the Diocese of Worcester but now in the said Diocese of Birmingham was assigned as a District Chapelry to the consecrated Church of Saint John situate at Knowle within the limits of such Parish and such District Chapelry was called ' The District Chapelry of Knowle '.

"And whereas the said District Chapelry of Knowle has under the provisions of the Act of the 19th and 20th years of Her said late Maiesty, Chapter 104, become a New Parish of the character contemplated by that Act, by the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, and by the above mentioned Act of the 32nd and 33rd years of Her said late Majesty, Chapter 94: "And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said New Farish should be altered in the manner which is hereinafter mentioned:

Now, therefore, with the consent of the Right Reverend Ernest William, Bishop of Birmingham (in testimony whereof he has signed and sealed this Scheme or Representation), we, the said Ecclesiastical Commissioners, humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme or Representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said New Parish of Knowle shall be altered so that all that portion of the Parish of Solihull, in the said County of Warwick and in the said Diocese of Birmingham which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan hereunto annexed and is thereon coloured pink shall be annexed to and shall in future form part of the said New Parish of Knowle.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the hereinbefore mentioned Acts, or any of them or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the New Parish of Knowle in the County of Warwick and in the Diocese of Birmingham being: —

" All that portion of the Parish of Solihull in the said County and Diocese which is bounded upon the south-east by the said New Parish of Knowle and upon the remaining sides, that is to say, upon the south-west, upon the northwest and upon the north-east by an imaginary line commencing upon the boundary which divides the said New Parish of Knowle from the said Parish of Solihull at a point to the north-east of Widney Road distant 41 chains from the middle of that road and extending thence north-westward in a line parallel to and distant $4\frac{1}{2}$ chains precisely from the middle of Widney Road for a distance of 58 chains or thereabouts to the middle of Brown's Lane and extending thence north-eastward along the middle of Brown's Lane for a distance of 33 chains or thereabouts to its junction with Lady Byron Lane and extending thence first northward and then north-eastward along the middle of Lady Byron Lane for a distance of 62 chains or thereabouts to its junction with the main road leading from Birmingham to Warwick and extending thence north-eastward across the last mentioned road to and along the wall or fence forming the north-western boundary of the closes numbered 1 and 2 upon the map or plan annexed to this Scheme or Representation for a distance in all of 33 chains or thereabouts to the western side of Jacobean Lane and extending thence eastward to and northward along the middle of Jacobean Lane for a distance of 1 chains or thereabouts to a point opposite to the south-western end of the north-western
