Revokes Orders Nos. 6037 and 6049 on 13th February, 1941, and contracts the Foot-and-Mouth Disease Infected Area around Kington St. Michael, Wilts., and Longford, Glos., to an area comprising the districts situate within approximately 5 miles around Kington St. Michael and those districts within 15 miles of Longford and Brookthorpe, Glos., which do not lie within the Infected Area around Breinton, Hereford, and Skenfrith, Monmouth.

The Minister of Agriculture and Fisheries hereby gives notice that the Lee Conservancy Catchment Board have made application under sub-section (3) of Section 5 of the Land Drainage Act, 1930, that the statutory map of the Catchment Area be varied so far as relates to the extent of the "main river" by the addition to the said "main river" of certain watercourses which discharge into the River Lee below Mill Green, Hatfield.
