At the Court at *Buckingham Palace*, the 30th day of *May*, 1941.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, duly prepared and laid before His Majesty in Council a Scheme bearing date the 1st day of May, 1941, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure of Camberwell (hereinafter called ‘ the said Benefice ’) in the County of Surrey and in the Diocese of Southwark:

“ Whereas we are satisfied that Laura Maitland Cochrane of Number 11 Ramsay Garden, Edinburgh, Spinster, as the Patron of the said Benefice may, with the consents of Humphrey David Richard Pelham Lindsay, of

Gadebridge Park, Hemel Hempstead, Hertfordshire, Schoolmaster, and Mary Anne Victoria Lindsay, of St. Giles' Vicarage, Camberwell, London, S.E.5, Spinster, as required by a Declaration of Trust dated the 26th day of October, 1922, relating to the advowson of the said Benefice, transfer the said advowson as herein proposed:

“ And whereas the said Laura Maitland Cochrane, Humphrey David Richard Pelham Lindsay and Mary Anne Victoria Lindsay have agreed to transfer the advowson of the said Benefice to the Bishop of Southwark for the time being (in testimony whereof they have executed this Scheme):

“ And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls:

Now, therefore, with the consent of the Right Reverend Richard, Bishop of Southwark (in testimony whereof he has executed this Scheme), we, the said Ecclesiastical Commissioners, recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice shall be transferred to the said Richard, Bishop of Southwark, and his successors in the same Bishopric and shall thenceforth be absolutely vested in and shall from time to time be exercised by the Bishop of Southwark for the time being.”

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct
