

recommendation to that effect by or through Our Prime Minister and First Lord of the Treasury, Our First Lord of the Admiralty, Our Secretary of State for War, or Our Secretary of State for Air, as the case may be, to cancel and annul the award to any person of the George Cross and that thereupon the name of such person in the Register shall be erased: provided that it shall be competent for Us, Our Heirs and Successors to restore the Decoration so forfeited when such recommendation has been withdrawn.

*Lately:* We reserve to Ourselves, our Heirs and Successors, full power of annulling, altering, abrogating, augmenting, interpreting, or dispensing with these rules and ordinances, or any part thereof, by a notification under Our Sign Manual.
