before His Majesty in Council a Scheme bearing date the 12th day of June, 1941, in the

England, in pursuance of the Act of the 33rd and 34th years of Her late Majesty Queen Victoria, Chapter 39, and of the Acts therein mentioned, that is to say, the Act of the 3rd and 4th years of Her said late Majesty, Chapter 113, the Act of the 4th and 5th years of Her said late Majesty, Chapter 39, and the Act of the 31st and 32nd years of Her said late Majesty, Chapter 114, have prepared and now humbly lay before Your Majesty in Council the following Scheme for effecting a transfer of the ownership of the Advowson or perpetual right of Patronage of and presentation to the Church and Cure (hereinafter called ' the said Benefice ') of Gringley on the Hill in the County of Nottingham and in the Diocese of Southwell:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Gringley on the Hill is vested in Mabel Catherine Owen wife of Ewin Tegid Owen of Merlin Haven Wotton-under-Edge in the County of Gloucester, Esquire, and the Reverend William Meade-King Warren of the Rectory, Binegar, in the County of Somerset, Clerk in Holy Orders as Executors of the Will dated the 1st day of August 1939 of the late Alice Maud Meade-King of Heleigh House, Box, in the County of Wilts, Spinster, and the said Mabel Catherine Owen and William Meade-King Warren are the persons entitled to present or nominate to the said Benefice in case the same were now vacant:

And whereas the said Mabel Catherine Owen and the said William Meade-King Warren are desirous that the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Gringley on the Hill now vested in them as aforesaid should be transferred to and be vested in the Bishop of Southwell, for the time being

"And whereas the Right Reverend Henry now Bishop of Southwell is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the Diocese which by the hereinbefore mentioned Acts or by some or one of them is made necessary he, the said Henry, Bishop of Southwell, has executed this Scheme as hereinafter mentioned :

And whereas the transfer of the Patronage of the said Benefice of Gringley on the Hill which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the Parish or District in or in respect of which the right of Patronage or Advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the Parish of Gringley on the Hill:

"Now, therefore, with the consent of the said Mabel Catherine Owen and William Meade-King Warren being the persons whose consent as Patrons is required by the provisions of the hereinbefore mentioned Acts and of the Act of the 1st and 2nd years of Her said late Majesty, Chapter 106 (in testimony whereof they have signed and sealed this Scheme) and with the consent of the said Henry, Bishop of Southwell (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), we, the said Ecclesiastical

Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson perpetual right of Patronage of and OT presentation to the said Benefice of Gringley on the Hill now vested in them, the said Mabel Catherine Owen and William Meade-King Warren as aforesaid, shall be transferred to the said Henry Bishop of Southwell and his successors in the same Bishopric, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Henry Bishop of Southwell and by his successors in the same Bishopric for ever:

And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any of them or of any other Act of Parliament."

And whereas the said scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Southwell.
