TENDERS FOR TREASURY BILLS.

 The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 25th July, 1941, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Acts, 1939 to 1941, to the amount of £75,000,000.

2. The Bills will be in amounts of £5,000, f10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 28th July, 1941. to Saturday, the 2nd August, 1941, inclusive, and will be payable at three months after date.

3. The Bills will be issued and paid at the

Bank of England.
4. Each Tender must be for an amount not less than £50,000, and must specify the date on which the Bills required are to be dated, and the net amount per cent. (being an even
