CENTRAL CHANCERY OF THE ORDERS OF KNIGHTHOOD.

St. James's Palace, S.W.1. 5th August, 1941.

The KING has been graciously pleased to approve the award of the George Medal to the undermentioned:—

Pilot Officer John Cyril Brice (60529), Royal Air Force Volunteer Reserve.

One night in April, 1941, this officer was the pilot of an aircraft which crashed on landing and burst into flames. When the aircraft came to rest it was burning fiercely. Pilot Officer. Brice removed his flying helmet, harness and parachute and attempted to open the top hatch. This was jammed however, so he went forward to get the hatchet. By this time the whole perspex nose of the aircraft was on fire and the heat intense. Failing to find the hatchet, Pilot Officer Brice returned and made further efforts with the sliding roof which he managed to get open, severely burning his left hand in the attempt. After getting clear he noticed that the rear hatch was still closed and, in spite of his burns and the fact that the wind was blowing the flames over this hatch, he returned to the aircraft and tried, with his undamaged hand, to open the hatch and release the gunner. Unable to do so, Pilot Officer Brice climbed on top of the fuselage and, holding the catch with his right hand, he jumped on to the hatch and succeeded in bursting it open. Although he had received further burns to his hand and face he remained there until the gunner was clear of the aircraft. This officer displayed great coolness and bravery throughout.

1063679 Leading Aircraftman Thomas John Clarke, Royal Air Force.

In May, 1941, this airman was undergoing night flying instruction in an aircraft which was attacked by an enemy aircraft as it was approaching to land. Leading Aircraftman Clarke received a bullet wound which caused a compound fracture of the right humerus rending the arm useless, while his instructor was hit in the stomach which paralysed both The aircraft was crash landed but legs. burst into flames on impact. With great determination Leading Aircraftman Clarke succeeded in opening the emergency roof exit and, in spite of his wound, managed to extricate his instructor, who was helpless, and remove him to a safe distance. Although greatly handicapped throughout, this airman displayed great determination, gallantry and presence of mind and undoubtedly saved his instructor from being burned alive. Unfortunately the instructor has since died of his wounds.

1014345 Aircraftman 1st Class Albert Jones, Royal Air Force

One morning in May, 1941, this airman drove his tender out on to the aerodrome to pick up the crew of an aircraft returning from operations. Whilst waiting in his tender a loud explosion occurred and the aircraft, which was only 10 yards away, burst into flames. Aircraftman Jones immediately drove his vehicle about 50 yards away to avoid its destruction and then ran back to the burning aircraft. With complete indifference to danger he dragged a badly wounded airman from the aircraft to a place of safety. Whilst so doing three more bombs exploded and he was wounded in the arm by a flying splinter but, undaunted, he continued his efforts, although he did not know how many more bombs might still be in the aircraft.

The KING has been graciously pleased to approve the award of the British Empire Medal (Military Division) to:—

852019 Leading Aircraftman William Aitkin Osborne, Auxiliary Air Force.

This airman was in charge of a balloon site one night in November, 1940. Several high explosive bombs had exploded on and around the site and he had ordered his crew to shelters. He observed his balloon dropping, due to shell splintered punctures, and led his crew to haul it in. This was successfully carried out during the attack. He later led three of his crew to the assistance of civilians who were trapped in a neighbouring de-molished house, but on his way he was rendered unconscious by a bomb explosion which killed two of his companions. Leading Aircraftman Osborne had, during a previous raid, led a relief party from his crew to trapped civilians. Нe has displayed gallantry and devotion to duty in keeping with the high tradition of the service.

ROYAL AIR FORCE.

The KING has been graciously pleased to confer the VICTORIA CROSS on the undermentioned airman in recognition of most conspicuous bravery:

NZ/401793 Sergeant James Allen WARD, Royal New Zealand Air Force, No. 75 (N.Z.) Squadron.

On the night of 7th July, 1941, Sergeant Ward was second pilot of a Wellington returning from an attack on Munster.

When flying over the Zuider Zee at 13,000 feet, the aircraft was attacked from beneath by a Messerschmitt 110 which secured hits with cannon shell and incendiary bullets. The rear gunner was wounded in the foot but delivered a burst of fire which sent the enemy

fighter down, apparently out of control. Fire then broke out near the starboard engine and, fed by petrol from a split pipe, gained an alarming hold quickly and threatened to spread to the entire wing. The crew forced a hole in the fuselage and made strenuous efforts to reduce the fire with extinguishers and even the coffee in their vacuum flasks, but without success. They were then warned to be ready to abandon the aircraft.

As a last resort, Sergeant Ward volunteered to make an attempt to smother the fire with an engine cover which happened to be in use as a cushion. At first he proposed to discard his parachute, to reduce wind resistance, but was finally persuaded to take it. A rope from the dinghy was tied to him, though this was of little help and might have become a danger had he been blown off the aircraft. With the help of the navigator, he then climbed through the narrow astro-hatch and put on his parachute. The bomber was flying at a reduced speed but the wind pressure must have been sufficient to render the operation one of extreme difficulty.

Breaking the fabric to make hand and foot holds where necessary, and also taking ad-vantage of existing holes in the fabric, Ser-geant Ward succeeded in descending three feet to the wing and proceeding another three feet to a position behind the engine, despite the slipstream from the airscrew, which nearly blew him off the wing. Lying in this precarious position, he smothered the fire in the wing fabric and tried to push the cover into the hole in the wing and on to the leaking pipe from which the fire came. As soon as he removed his hand, however, the terrific wind blew the cover out and when he tried again it was lost. Tired as he was, he was

able with the navigator's assistance, to make successfully the perilous journey back into the aircraft.

There was now no danger of the fire. spreading from the petrol pipe, as there was no fabric left nearby, and in due course it When the aircraft was. burnt itself out. nearly home some petrol which had collected. in the wing blazed up furiously but died down quite suddenly. A safe landing was then made despite the damage sustained by the aircraft. The flight home had been made possible by the gallant action of Sergeant Ward in extinguishing the fire on the wing. in circumstances of the greatest difficulty and at the risk of his life.

ROYAL AIR FORCE.

The KING has been graciously pleased to approve the following awards in recognition of gallantry displayed in flying operations against the enemy:

Distinguished Service Order.

Wing Commander Charles Henry APPLETON, D.F.C. (24139), No. 604 Squadron.

This officer has commanded the squadron since February, 1941, and by his sound organisation, drive, energy, and high skill in flying has enabled it to attain a splendid record in night fighting. Whilst under his inspiring leadership, the squadron has destroyed at least 45 enemy aircraft at night and damaged many others. He has personally destroyed two and damaged two enemy aircraft.

Wing Commander John Ralph Alexander

PEEL, D.F.C. (33011). Since March, 1941, this officer has led the wing over France on twenty-eight occasions and, under his leadership, it has destroyed thirty-two enemy aircraft. In April, 1941, he led a formation of five aircraft on a successful low flying machine-gun attack against Berck and damaged or destroyed three Messerschmitt 109's. One afternoon in July, 1941, he was shot down off the French coast but, despite this experience, he led the wing the next morning. The success of the wing in escorting and destroying enemy aircraft has been due to Wing Commander Peel's training and leadership.

Squadron Leader Michael Lister ROBINSON, D.F.C. (37300), No. 609 Squadron.

This officer has commanded the squadron since October, 1940. He has acted as leader in recent offensive operations over occupied territory and, on numerous occasions, has led his wing with determination, skill and cour-The successes obtained reflect the age. greatest credit on the leadership and devotion to duty of this officer. He has destroyed at least fourteen enemy aircraft and damaged others.

Bar to the Distinguished Flying Cross.

Acting Squadron Leader Percival Stanley TURNER, D.F.C. (41631), No. 145 Squadron. This officer has led his squadron on all sweeps over France and has set a splendid example by his quiet coolness in the face of the enemy. He has been responsible for the destruction of at least twelve enemy aircraft.

Distinguished Flying Cross.

Squadron Leader Herbert Laurence PRICE (70555), Reserve of Air Force Officers, No. 218 Squadron.

One night in July, 1941, this officer was detailed to attack Duisberg. In spite of searchlight concentration and heavy antiaircraft fire, he spent 40 minutes locating the target, which was eventually successfully bombed. His aircraft was repeatedly hit and the rear turret put out of action. Over Holland, on the return journey, his aircraft was intercepted by an enemy aircraft which was shaken off by skilful avoiding action. The port engine failed and his aircraft began to lose height rapidly. All available articles were jettisoned but Squadron Leader Price was nevertheless compelled to fly at 600 feet. By skilful piloting, however, he landed safely at his base. He has always shown the utmost coolness, courage and determination.

- Flight Lieutenant Leslie Fox (36099), No. 209 Squadron.
- Acting Flight Lieutenant Roger Edward HUNTER (40540), No. 240 Squadron.

• These captains of aircraft have completed 500 and 850 operational flying hours respectively and have always shown outstanding zeal, cheerfulness and courage in their flying duties. On two occasions they have carried out important duties involving long distance flights during which the weather conditions were most adverse and navigational aids were almost non-existent. In the successful completion of these most responsible tasks they showed fine determination and a very high standard of airmanship.

Flight Lieutenant Roland Anthony Lee KNIGHT (37772), No. 610 Squadron.

This officer has shown great personal courage and sound leadership in sweeps over enemy territory. By his dash and consistent courage Flight Lieutenant Knight has set an example to his flight. He has destroyed at least three enemy aircraft and damaged others.

Acting Flight Lieutenant Hugh Spencer Lisle DUNDAS (91001), Auxiliary Air Force, No. 616 Squadron.

This officer has shown unflagging courage in the face of the enemy and the utmost tenacity in supporting his leader. He has destroyed at least three enemy aircraft and damaged others.

Flying Officer Geoffrey Harry Augustus WELLUM (42925), No. 92 Squadron.

This officer has been with his squadron since the evacuation from Dunkirk. During the recent offensive operations over France he has led his section and flight with great skill and determination. He has destroyed at least three enemy aircraft and damaged several others.

Acting Flying Officer Geoffrey HALL (81638), Royal Air Force Volunteer Reserve, No. 61 Squadron.

One night in July; 1941, this officer, as captain of aircraft, was detailed to attack a target at Aachen. Shortly before reaching the target area the aircraft, while held by about twenty searchlights, was attacked from astern by an enemy fighter. The starboard petrol tank, mainplane, wings, fuselage and tailplane were all hit. The gunner succeeded, however, in driving off the enemy. Despite the damage to his aircraft Flying Officer Hall flew on to the target and made four runs over it at 5,000 feet before dropping his bombs. This officer's previous record is excellent and he has consistently shown a high degree of courage and determination on operations which is unsurpassed.

Acting Flying Officer Dennis Theodore WITT, D.F.M. (44867), No. 7 Squadron.

D.F.M. (44867), No. 7 Squadron. In July, 1941, this officer led three aircraft to bomb a target near Bethune. When the section crossed the enemy coast it was subjected to intense anti-aircraft fire which shot down one aircraft of the section. Unperturbed, however, Flying Officer Witt led the remaining aircraft in a determined attack on the target in the face of another intense anti-aircraft barrage. The success of this attack was due to the tenacity, skill and determination of Flying Officer Witt. Ten days previously, while raiding Texel, he enabled his rear gunner to destroy a Messerschmitt 109. He is an outstanding pilot who has gained notable successes against the enemy.

Pilot Officer Brian Lawless DUIGAN (43377), No. 70 Squadron.

One night in July, 1941, this officer was captain of an aircraft which made a successful dive-bombing attack on shipping in Benghazi harbour, in the face of intense and accurate anti-aircraft fire. After dropping his bombs he silenced several of the light batteries with machine-gun fire. On the return journey he caused damage by machine-gun fire to an army encampment. another night Pilot Officer Duigan On attacked aircraft on Nasrulla aerodrome. On the fourth run over the target he was attacked vigorously from all directions by three enemy fighters. Severe damage was caused to his aircraft but, in spite of this, he manoeuvred it so as to afford his gunners the best possible firing positions, and then gave them cool encouragement over the damaged inter-communication gear. Despite lack of instruments Pilot Officer Duigan brought the aircraft through the mountains to the sea. Preferring to make for base where much needed spares were stored, he refused to land on a flare-path at Lydda. Un-fortunately he was unaware of his low air speed due to excessive drag, and was compelled to make a forced landing. He has shown great coolness, resource and tenacity of purpose.

Pilot Officer Frederick Anthony Owen GAZE (60096), Royal Air Force Volunteer Reserve, No. 610 Squadron.

This officer has shown a persistent desire to engage the enemy on all occasions. In a recent combat he undoubtedly saved his squadron commander from being shot down over enemy territory by destroying his two attackers. He has now destroyed at least three enemy aircraft. Pilot Officer John Everard Hadfield MARSHALL (42622), No. 37 Squadron

Pilot Officer Kenneth Stanley PETERSON (N.Z.406218), Royal New Zealand Air Force, No. 37 Squadron.

One night in July, 1941, these officers were the pilot and navigator bomb aimer respectively of an aircraft detailed to attack an enemy fuel depot. The target area was obscured by cloud and Pilot Officer Marshall found it necessary to descend to 2,500 feet to locate the objective. The first run was made in the face of intense anti-aircraft fire, the aircraft being hit in several places. Some bombs were dropped but the attack was not considered satisfactory. A second run was made but Pilot Officer Peterson decided not to release his remaining bombs because he had not a sufficiently good sight of the target. On the third run direct hits on the storage tanks were obtained. Pilot Officers Marshall and Peterson displayed outstanding courage, devotion to duty and skill under difficult and dangerous conditions.

Distinguished Flying Medal.

967894 Sergeant Gerald Harcourt Rawlings POLSON, No. 57 Squadron.

One night in July, 1941, this airman was the rear gunner of an aircraft which was attacked by a Junkers 88 when returning across the North Sea. Holding his fire until the attacker was within 200 yards, Sergeant Polson fired a burst from each gun. The Junkers passed overhead and returned for another attack. The pilot had, however, manoeuvred the aircraft so as to enable Sergeant Polson to meet this attack; he fired 40 rounds from each gun and the enemy aircraft dived into the sea in flames. Six nights previously he successfully defended his aircraft against an attack by a Messerschmitt 110. He has at all times shown courage and efficiency.

CAN.60727 Sergeant Mark ROACH, Royal Canadian Air Force, No. 7 Squadron.

This airman was the air observer of one of a section of three aircraft which was detailed to attack a target near Bethune. When the section crossed the enemy coast it was subjected to intense anti-aircraft fire, one of the aircraft being shot down. On approaching the target the two remaining aircraft were again subjected to anti-aircraft fire. Despite this and the fact that his pilot was taking evasive action, Sergeant Roach carefully and successfully bombed the target. The success of this high level attack under extremely difficult conditions was largely due to the courage and concentration of Sergeant Roach.

Notice is hereby given in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made the following Order: —

Order No. 6158.

(Dated 1st August, 1941.)

Animals (Landing from Eire, Northern Ireland and Isle of Man) (Amendment) Order of 1941 (No. 10).

Subject.

I. Revokes the Animals (Landing from Eire, Northern Ireland and Isle of Man) (Amendment) Orders of 1941 (Nos. 8 and 9), on 5th August, 1941.

II. Allows the importation at Birkenhead and Glasgow of cattle, sheep, goats or swine from Northern Ireland; and from that part of Eire situate north and west of a line drawn from Dublin along the Grand Canal to Shannon Harbour and thence along the River Shannon to its mouth, if shipped at the ports of Dublin, Dundalk or Drogheda, or from the counties of Limerick, Kerry or Cork if shipped at the port of Cork. Animals must be slaughtered at the landing place within 96 hours of landing.
