SUPREME COURT OF JUDICATURE
(CONSOLIDATION) ACT, 1925, SECTION
51.

The following Order has been made by the High Court of Justice against Mr. Robinson Woods, of 9A, Rosslyn Road, Twickenham, Middlesex.

Wednesday the 30th day of July 1941.

In the High Court of Justice, King's Bench Division. In the Matter of the Supreme Court of Judicature (Consolidation) Act, 1925, Section 51, and in the Matter of Robinson Woods.

Upon the Motion of and upon hearing Mr. Attorney General of Counsel for the Ministry of Agriculture and Fisheries and Mr. Holroyd Pearce of Counsel for Robinson Woods and upon reading the several affidavits of Sir Raymond Wybrow Woods, Andrews Denys Stocks and Frank Warburton Lawton filed in support of such Motion and the affidavit of Robinson Woods filed in opposition thereto.

It is ordered that no legal proceedings shall be instituted by the said Robinson Woods in the High Court or in any other Court unless he obtains the leave of the High Court or of some Judge thereof and satisfies the Court or Judge that such legal proceedings are not an abuse of the process of the Court and that there is a prima facie ground for such proceedings.
