"Whereas we are satisfied that Henry William Ferdinand Bolckow of Marton-in-Cleveland in the said County of York, Esquire, is the patron or person entitled to present or nominate to the said benefice in case the same were now vacant:

"And whereas the said Henry William Ferdinand Bolckow desires to transfer the advowson of the said benefice to the Archbishop of York for the time being and is consenting to this Scheme (in testimony whereof he has executed the same):

"And whereas we are satisfied that the transfer will tend to make better provision for the cure of souls:

"Now, therefore, with the consent of the Right Honourable and Most Reverend William, Archbishop Honourable and Most Reverend William, Archbishop of York (in testimony whereof he has executed this Scheme) we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole advowson or perpetual right of patronage of and presentation to the said Benefice of Scawton with Cold Kirby shall be transferred to the said William Archbishop of York, and his successors in the same Archbishopric and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Archbishop of York for the time being."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual

in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Voels.

STATUTES TO AMEND THE STATUTES OF THE COLLEGE CONCERNING SCHOLARS AND EXHIBITIONS BURSARIES.

We, the Warden and Fellows of Winchester College, being the Governing Body of Winchester College, do hereby, in exercise of the powers of the Public Schools Act, 1868, and of the Acts amending the same, and of all other powers enabling us in that behalf, resolve and enact as follows:—

A Statute for further amending Statutes of the College concerning Scholars.

1. Subject to the other provisions of this Statute, every Scholar of the College hereafter admitted shall pay the annual sum of one hundred guineas, which shall be paid in such instalments and at such times as the Warden and Fellows may from time to time direct. Subject to such payment, the Scholars shall be maintained and educated during their residence at School out of the income of the College. School out of the income of the College:
