The KING'S Most Excellent Majesty in Council.

WHEREAS by the Extradition Acts, 1870 to 1935 (33 & 34 Vict. c. 52; 36 & 37 Vict. c. 60; 58 & 59 Vict. c. 33; 6 Edw. 7. c. 15; 22 & 23 Geo. 5. c. 39; 25 & 26 Geo. 5. c. 25), it was amongst other things enacted that, where an arrangement has been made with any foreign State with respect to the surrender with any foreign State with respect to the suffender to such State of any fugitive criminals, His Majesty may, by Order in Council, direct that the said Acts shall apply in the case of such foreign State: and that His Majesty may, by the same or any subse-quent Order, limit the operation of the Order, and restrict the same to fugitive criminals who are in or suspected of being in the part of His Majesty's

restrict the same to fugitive criminals who are in or suspected of being in the part of His Majesty's dominions specified in the Order, and render the operation thereof subject to such conditions, excep-tions and qualifications as may be deemed expedient: And whereas by Orders in Council dated the 21st March, 1890, the 26th June, 1901, and the 11th February. 1907, the Extradition Acts, 1870 to 1906, were respectively made applicable in the case of the United States of America under and in accordance with the several Conventions concluded between His Majesty and the President of the United States on the 12th July, 1889, the 13th December, 1900, and the 12th April, 1905: And whereas, under the provisions of Article 14 of the Treaty signed on the 22nd day of December, 1931, between His Majesty and the President of the United States of America for the mutual extradition

United States of America for the mutual extradition United States of America for the mutual extradition of fugitive criminals, the terms whereof were recited in the United States of America (Extradition) Order in Council, 1935, His Majesty has acceded to the said Treaty on behalf of India: And whereas in accordance with the provisions of Article 18 of the said Treaty, on the coming into force thereof, the above-mentioned Conventions and the provisions of Article 10 of the Treaty signed on

the provisions of Article 10 of the Treaty signed on the 9th August, 1842, between Her late Majesty Queen Victoria and the President of the United States of America will cease to have effect in respect of India on the accession of that territory to the end Treaty: said Treaty:

Now, therefore, His Majesty, by and with the advice of His Privy Council, and in virtue of the authority committed to Him by the said recited Acts, doth order, and it is hereby ordered, as follows:

(1) From and after the 9th day of March, 1942, the Extradition Acts, 1870-1935, shall apply in respect of India in the case of the United States of America under and in accordance with the said

Treaty of the 22nd December, 1931: (2) From and after the 9th day of March, 1942, the said Orders in Council shall be revoked in so far as they relate to India.

This Order may be cited as the "United States of America (Extradition: India) Order in Council, 1942".

The Bills will be in amounts of £5,000, £10,000, £50,000 or £100,000. They will be dated at the option of the tenderer on any business day from Monday, the 9th March, 1942, to Saturday, the 14th March, 1942, inclusive, and will be payable at three months after date. 3. The Bills will be issued and paid at the Bank of England.
