CHANCERY OF THE ORDER OF SAINT MICHAEL AND SAINT GEORGE.

25th February, 1942.

The KING, as Sovereign of the Most Distinguished Order of Saint Michael and Saint George, has been graciously pleased to appoint Lieutenant-Colonel the Right Honourable the Earl of Clarendon, K.G., G.C.M.G., G.C.V.O., to be Chancellor of the Order in succession to the late Marquess of Willingdon.
