ROYAL WARRANT. GEORGE R.I.

GEORGE the SIXTH, by the Grace of God, of Great Britain, Ireland and the British Dominions beyond the Seas, King, Defender of the Faith, Emperor of India; To all to whom these Presents shall come.

Greeting.

Whereas We did, by a Warrant under Our Sign Manual, dated 22nd September, 1940, amend and consolidate the regulations governing the two decora-tions designated the Distinguished Flying Cross and the Air Force Cross, and the two medals designated the Distinguished Flying Medal and the Air Force Medal, and did direct that the regulations so amended and consolidated and incorporated in the said Roval Warrant should be the regulations governsaid Royal Warrant should be the regulations govern-ing the said decorations and medals;

And Whereas the said Royal Warrant was amended by a Royal Warrant dated 11th March 1941;. And Whereas we deem it expedient that a further alteration should be made in the regulations govern-

Iteration should be made in the regulations govern-ing the said decorations and medals; Now, Therefore, We do by these Presents for Us, Our Heirs and Successors, ordain that the following regulations shall be substituted for the corresponding regulations in the Royal Warrant dated 22nd September 1940 and shall henceforth be construed and have the same effect as if they formed part of the said Royal Warrant:—

13. Eligibility. (1) The Distinguished Flying Cross shall be granted to such officers and warrant officers, and the granted to such officers and warrant officers, and the Distinguished Flying Medal to such non-com-missioned officers and aircraftmen, as shall be recom-mended to Us by or through Our Secretary of State for Air (or, in the case of any of Our Dominions the government whereof shall so desire, the appropriate Minister of State for the said Dominion), for excep-tional valour, courage or devotion to duty whilst flying in active operations against the enemy. (2) The Air Force Cross shall be granted to such officers and warrant officers, and the Air Force Medal to such non-commissioned officers and aircraft-men, as shall be recommended to Us by or through

Medal to such non-commissioned onicers and aircratt-men, as shall be recommended to Us by or through Our Secretary of State for Air (or, in the case of any of Our Dominions the government whereof shall so desire, the appropriate Minister of State for the said Dominion), for exceptional valour, courage or devotion to duty whilst flying, though not in active operations against the enemy.

Bars.

14. Bars. When an individual who has been awarded one of medals shall again be the above decorations or medals shall again be recommended to Us by or through Our Secretary of State for Air (or, in the case of any of Our Dominions the government whereof shall so desire, the appro-neits division of State for the soil Dominion's for the government whereof shall so desire, the appro-priate Minister of State for the said Dominion), for further exceptional valour, courage or devotion to duty, he shall be awarded a bar to be attached to the ribbon by which the decoration or medal is suspended, and for every additional such recom-mendation an additional bar may be awarded. For every bar awarded a small silver rose shall be added to the ribbon when worn alone.

to the ribbon when worn alone. 17. Forfeiture and restoration. (1) It shall be competent for Us, Our Heirs and Successors by an Order under our Sign Manual and on a recommendation by or through Our Secretary of State for Air (or, in the case of any of Our Dominions the government whereof shall so desire, the appropriate Minister of State for the said Dominion), to cancel and annul the award to any person of the above decorations or medals and thereupon the name of such person in the register shall be erased; but We, Our Heirs and Successors shall at all times have power to restore any decora-tion or medal which may have been forfeited when such recommendation shall have been withdrawn.

Given at Our Court at Saint James's this twentythird day of February, 1942, in the sixth year of Our Reign.

Distinguished Service Order.

Flight Lieutenant Adrian WARBURTON, D.F.C.

light Lieutenant Adrian WARBURTON, D.F.C. (41635). This officer has carried out many missions each of which has demanded the highest degree of courage and skill. On one occasion whilst carry-ing out a reconnaissance of Taranto, Flight Lieutenant Warburton made 2 attempts to pene-trate the harbour, although as there was much low cloud this entailed flying at a height of 50 feet over an enemy battleship. In spite of the failure of his port engine and repeated attacks from enemy aircraft, he completed his mission and made a safe return. On another occasion he ob-tained photographs of Tripoli in spite of enemy fighter patrols over the harbour. In March, 1942, Flight Lieutenant Warburton carried out a recon-naissance of Paleimo and obtained photographs naissance of Paleimo and obtained photographs revealing the damage caused by our attacks. This officer has never failed to obtain photographs from a very low altitude, regardless of enemy opposition. His work has been most valuable and he has displayed great skill and tenacity.

he has displayed great skill and tenacity. Distinguished Flying Cross. Acting Squadron Leader Edward Charles Crocker TOMKINS (39910), No. 37 Squadron. One night in March, 1942, Squadron Leader Tomkins, as senior captain of aircraft, partici-pated in a successful attack on Palermo. He spent a considerable time over the harbour, in the face of intense anti-aircraft fire, before making his attack. He succeeded in setting a large enemy merchant vessel on fire, thereby assisting other aircraft in locating the target area in subseenemy merchant vessel on nre, thereby assisting other aircraft in locating the target area in subse-quent attacks. As a result of the operation, 2 enemy vessels of 6,000 tons were sunk and one 9,000-ton vessel was severely damaged. Con-siderable damage was also caused to harbour installations. The successes achieved were largely due to Squadron Leader Tomkins's courage and determination. largely due to Squadron courage and determination.

Distinguished Flying Medal.

AUS./402052 Sergeant Leonard Graham FULLER, Royal Australian Air Force, No. 37 Squadron. One night in March, 1942, this airman was cap-tain of an aircraft which participated in an attack on Palerme, when 2 enemy vessels of 6,000 tons were sunk, another severely damaged, and much destruction was caused to harbour installations. Having set one of the enemy vessels on fire, this airman flew back to his base for his aircraft to be refuelled and re-armed. He then returned to the target and after making a second attack on the ships, remained over the area for some time in order to prevent fire-fighting parties from washing. working.

777952 Aircraftman 1st Class Ronald Dudley Keith HADDEN, Royal Air Force Volunteer Reserve.

This airman has accompanied Flight Lieutenant Warburton on all his operational flights and has Warburton on all his operational lights and has displayed great keenness and devotion to duty. On numerous occasions, when his aircraft has been attacked by enemy fighters, Aircraftman Hadden has given valuable assistance to his pilot by informing him of the position and movements of the attacking aircraft. On all occasions this airman has shown great coolness in the face of the enemy and has thus done much to ensure their safe return. He has set an excellent example to all. safe return.
