WHEREAS the Ecclesiastical Commissioners for England have duly prepared and laid before His Majesty in Council a Scheme bearing date the 12th day of March, 1942, in the words and figures follow-

ing, that is to say:—
"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measures, 1923 to 1936, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the of the Parish of Shillington, partly in the County of Hertford and of the Parish of Shillington, partly in the County of Bedford and partly in the said County of Hertford, and both in the Diocese of Saint Albans:

"Whereas it appears to us the said Ecclesiastical Commissioners, to be desirable that the boundaries of the said Parish or the Market of the Shared in t

of the said Parishes should be altered in the manner

hereinafter mentioned:

"And whereas the Bishop of the Diocese and the Incumbents of the Benefices concerned consent to the proposed arrangements (in testimony whereof

to the proposed arrangements (in testimony whereof they have signed this Scheme):

"Now, therefore, we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any assurance in the law other than such duly gazetted Order the boundaries of the said Parish of Hexton and of the said Parish of Shillington shall be altered in the manner described in the Schedule of and delineated on the map or plan annexed to this Scheme.

"The Schedule to which the foregoing Scheme has reference:

"The territory (shown by pink colour on the map) to be annexed to the Parish of Hexton, in the county of Hertford and in the Diocese of Saint Albans, being:

"All that portion of the Parish of Shillington

Albans, being:—

"All that portion of the Parish of Shillington situate partly in the County of Bedford and partly in the said County of Hertford and wholly in the said Diocese of Saint Albans which is bounded upon the west by the said Parish of Hexton, upon the south partly by the Parish of Lilley and partly by the Parish of Offley, upon the east by the Parish of Pirton, all in the said County of Hertford and in the said Diocese of Saint Albans, and upon the remaining side that is to say, upon the north by remaining side, that is to say, upon the north by an imaginary line commencing upon the boundary which divides the said Parish of Pirton from the said Parish of Shillington at the eastern end of the wall or fence forming the southern boundary of the close numbered I upon the map or plan annexed to this Scheme and extending thence westward along the said wall or fence and along the wall or fence

forming the southern boundary of the closes numbered 2 and 3 upon the said map or plan for a distance of 69½ chains to the road leading from Pegsdon to Shillington and extending thence westward to and northward along the middle of the said road for a distance of 6½ chains to a point opposite the eastern end of the wall or fence forming the southern boundary of the close numbered 4 upon the same map or plan and extending thence westward same map or plan and extending thence westward to and along the last mentioned wall or fence to its western end and in a straight line in continuation thereof for a distance in all of 25 chains to the boundary which divides the said Parish of Shillington from the said Parish of Hexton."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1936, and the Union of Benefices Rules, 1926 to 1930, relating to the preparation and submission of this Scheme have been
