A STATUTE made by the Governing Body of Pembroke College, in the University of Cambridge, on the 12th April, 1943, amending Statute XI of the College Statutes has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1923."

REGULATIONS MADE IN PURSUANCE OF SECTION 13 OF THE ARCHITECTS (REGISTRATION) ACT, 1931, AMENDING THE EXISTING REGULATIONS.

Regulation 17.

Regulation 17 shall be amended so as to read as follows:

Regulation 17 shall be amended so as to read as follows:— "(a) A casual vacancy arising from the death or resignation of a member of the Council, the Board, the Admission Committee or the Discipline Com-mittee shall be filled as soon as may be by the body by which such member was appointed or elected in pursuance of the principal Act and in the like manner, provided that in the event of such vacancy arising among the persons elected to repre-sent 'Unattached Architects,' as hereinafter defined, the remaining representatives of the 'Unattached Archi-tects' on the Council shall elect a registered person to fill the vacancy. The person appointed or elected to fill such vacancy shall retain office so long only as the vacating member would have retained the same if no vacancy had occurred. "(b) A casual vacancy arising from the death or resignation of a member of the Finance and General Purposes Committee and other Committees appointed under Regulation 14 shall be filled by the Council as soon as may be."
