win tend to make better provision for the cure of souls: "Now, therefore, with the consent of the Right Reverend Frank Russell, Bishop of Southwell (in testimony whereof he has executed this Scheme), we, the said Ecclesiastical, Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any con-veyance or assurance in the law other than such duly gazetted Order the whole addressed or or perpetual right of patronage of and presentation to the said Benefice of Normanton on Soar shall be transferred to the said Frank Rüssell, Bishop of Southwell, and his successors in the same Bishopric and shall thereugon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the Bishop of Southwell for the time being."

And whereas the said Scheme has been approved by His Majesty in Council. Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to
