Article 2:--"2A Entitlement.--(I) The disablement or death of a member of the naval forces shall be accepted as due to war service for the purpose of these Regulations provided it is certified that—

 (a) the disablement is due to a wound, injury or disease which—

(i) is attributable to war service, or (ii) existed before or arose during war service and has been and remains aggravated thereby;

(b) the death was due to or hastened by-

(i) a wound, injury or disease which was attributable to war service; or
 (ii) the aggravation by war service of a wound, injury or disease which existed before or arose

during war service.

during war service. (2) In no case shall there be an onus on any claimant under these Regulations to prove the fulfilment of the conditions set out in paragraph (r) of this Article and the benefit of any reasonable doubt

(3) Where an injury or disease which has led to a member's discharge or death during war service was not noted in a medical report made on that member on the commencement of his war service, a certificate under paragraph (1) of this Article shall be given unless the evidence shows that the conditions set out in that paragraph are not fulfilled. (4) Where there is no note in contemporary official

(4) Where there is no note in contemporary official records of a material fact on which the claim is based, other reliable corroborative evidence of that fact may be accepted."
2. In Article 4 for the words "who is then or later certified to be disabled in consequence of a disability attributable to naval service during the war" there shall be substituted the words "whose disablement is due to war service."

Captain Rae and Mr. Payne have shown courage of a high order over an extended period in flying unarmed aircraft on the civil war-time air service between the United Kingdom and Stockholm. When Captain Rae was attacked over enemy-occupied territory his aircraft was damaged by cannon fire and the undercarriage hydraulic system was put out of action. By the most skilful evasive tactics and by exceptional coolness in a most hazardous situation he was able to avoid further damage, to shake off his assailant and eventually to make a forced-landing in Sweden with the undercarriage retracted. The forced-landing was made with such skill that compara-tively little damage was done to the aircraft. A few days later Captain Rae was again attacked by two German aircraft but by his skill and coolness he was able to shake off his assailants and land safely.

On a third occasion, half-way across the North Sea with a very heavy load, one of his engines

failed and it was only due to superb airmanship that he managed to get back to base. On each of these occasions Mr. Payne has been the Radio Officer of the aircraft. He has cheer-fully and readily accepted the same risks as his pilot. His skill as a Radio Officer and his cool-ness in the face of extreme danger have been out-standing. standing.
