TENDERS FOR TREASURY BILLS

WORKMEN'S COMPENSATION ACTS, 1925-1943.

The Secretary of State for the Home Department hereby gives notice that on the 29th November, 1943, he made a Scheme under Section 47 of the Workmen's Compensation Act, 1925 (as extended by the Workmen's Compensation (Silicosis and Asbestosis) Act, 1930, and the Workmen's Compensation Act, 1943) and Section 6 of the Workmen's Compensation (Supplementary Allowances) Act, 1940 (as extended by Section 3 of the Workmen's Compensation (Temporary Increases) Act, 1943).
