At the Court at Windsor Castle, the 10th day of December, 1943.

PRESENT,

The KING's Most Excellent Majesty in Council.

WHEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 29th day of November, 1943 (N.28535/43), in the words following, viz.:—

"Whereas by Section 3 of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia that all pay, pensions or other allowances in the nature thereof payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman or Marine therein shall be paid in such manner and subject to such restrictions, conditions and provisions as are from time to time directed by Order in Council:

"And whereas by Order in Council bearing date the 5th July, 1929, provision is made for payment of allowances to the Senior Cook or Cook (S) rating employed under the General Mess system in ships and establishments, other than R.N. Barracks, with 250 or more in the General Mess:

"And whereas there are a number of establishments having messes where the victualling allowance is pooled, and the food is obtained, prepared in the raw state and cooked in bulk:

"And whereas we consider that in such messes precisely the same work is required of the Senior Cook rating as would be required in a General Mess correctly so described:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction payment to the Senior Cook rating employed in a ship or establishment victualling 250 or more where, although the Ship's Company is messed on the victualling allowance system, the victualling allowance is pooled and the responsibilities of the Senior Cook rating are similar to those in a General Mess, as follows:—

" Note.—In Establishments where the Mess is divided into Blocks with separate galleys, the allowances may be paid in respect of each block providing for 250 or more ratings.	

"The Lords Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

His Majesty, having taken the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed.

And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

TENDERS FOR TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Friday, the 24th December, 1943, at 1 p.m., for Treasury Bills to be issued under the Treasury Bills Act, 1877, the National Debt Act, 1889, and the National Loans Act, 1939 to 1943, to the amount of £90,000,000.

(being an even multiple of one penny) which will be given for the amount applied for. Separate Tenders must be lodged for Bills of different dates.

5. Tenders must be made through a London Banker, Discount House or Broker.

6. The persons whose Tenders are accepted will be informed of the same not later than the following day, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England by means of Cash or a Banker's Draft on the Bank of England not later than 1.30 p.m. (Saturday 12 noon) on the day on which the relative Bills are to be dated.

7. Members of the House of Commons are not precluded from tendering for these Bills.

8. Tenders must be made on the printed forms which may be obtained from the Chief Cashier's Office, Bank of England.

EXPLOSIVES ACT, 1875.

The Secretary of State for the Home Department gives notice that he proposes to make an Order amending (i) the proviso to byelaw 2 in the Order of the Secretary of State (No. 11) (S.R. & O. 1924, No. 1129) as amended by the Order of the Secretary of State No. (11A) (S.R. & O., 1939, No. 1787) so as to increase, subject to certain conditions, the number of detonators and electric detonators which may be conveyed in the same carriage or boat with explosive of another Class or Division from 6,000 to 10,000 and (ii) regulation (p) contained in byelaw 4 in the said Order of the Secretary of State (No. 11) so as to increase the quantity of explosive which may be conveyed in any one carriage enclosed on all sides with wood or metal from 4,000 lb. to 6,000 lb.

(1) Partly to repeal the Workington Corporation Act, 1899 (hereinafter called "the local Act") by abrogating Article 3 of the Indenture (hereinafter called "the agreement") dated the 9th November, 1898, which is set forth in Part I. of the Second Schedule to the local Act;

(2) For the several purposes of the application or for purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said local Act, or of any other local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the Borough of Workington as may be necessary or desirable;

And whereas by section 21 of the local Act the provisions of the agreement were confirmed and made binding on the parties thereto;

And whereas the Rural District Council of Cockermouth (hereinafter called "the Rural Council") was a party to the agreement;

And whereas in the year 1894 the Corporation made application to the Local Government Board to extend the boundaries of the Borough by the inclusion therein of a portion of the district of the Rural Council known as "North Side" and in consideration of the provisions contained in the agreement the said application was agreed to by the Rural Council so far as concerned the water supply to North Side;

And whereas the said Article 3 of the agreement provides, *inter alia*, that the Corporation shall on and after the inclusion of North Side in the Borough make contributions to the Rural Council towards the expense of maintaining distributing water mains outside North Side and of repairs fittings salaries wages of officers and servants and such other items of annual expenditure as may from time to time be paid by the Rural Council and chargeable as general expenses, and that the amount of such con-

tributions shall be one-third of the expense afore-said;
